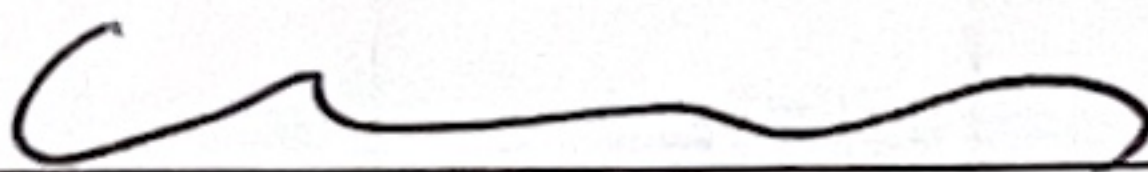

The above charity (unit) is an unincorporated association. It has no written constitution, but operates in accordance with the Guiding Manual, published by Girlguiding UK the operating name of the Guide Association.

Its Trustees are the volunteer adult leaders trained and appointed as guiders in terms of the guiding manual. Annual up date training is available throughout the year.

The charity's aim is to deliver a programme of informal education in accordance with the ethos and principles of Girlguiding UK. During the above period the charity provided this programme to 12 girls.

The charity's main income is subscription income. The charity aims to hold sufficient cash funds to meet all expenditure due and anticipated during a 2 month period.

There was a duplicate expense payment to one of the leaders of £172.22 which has now been repaid.

Income relating to trips is higher this year as we arranged a visit from The Animal Man for rainbows and rangers and the rangers contribution is included in this amount.

The cost of our sleepover was significantly less than expected, so there was a surplus, even after a £5 refund had been given to every rainbow. £30 has been spent on new pens for the district rainbows to share and the rest will be spent on resources during the current financial year.

During the year the trustees did not receive any remuneration.
