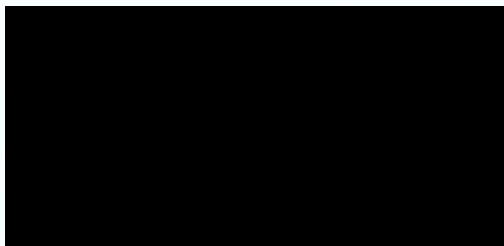
DUNDEE SPINNERS TRUST SC048556
