TRUSTEES' ANNUAL REPORT, YEAR ENDED 31 DECEMBER 2023

Structure, Governance and Management

Governing Document

The Church is administered in accordance with the terms of the Deed of Constitution (Unitary Form).

Recruitment and Appointment of Trustees

Members of the Kirk Session are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The minister, who is a member of the Kirk Session, is elected by the congregation and inducted by Presbytery.

Organisational Structure

Lundie and Muirhead Parish Church of Scotland is linked with Fowlis and Liff Parish Church. Lundie and Muirhead operates under the Unitary Constitution with a Kirk Session moderated by the Minister which meets six times a year. There are also Stewardship, Fundraising and Finance Workgroups.

During 2023 Lundie & Muirhead, Fowlis & Liff and Auchterhouse Parish Churches worked towards becoming a union. With this in mind all three congregations worship together once a month and share some social activities. One Finance Group and one Fabric/Property Group have been formed and the three Kirk Sessions now have some joint meetings. The Churches were formally united on 1 February 2024. The congregations are also part of the Carse and Northwest Grouping and participate in worship and social events in the group.

Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

A joint service with Fowlis and Liff is held at St. Marnock's Church on the first Sunday of the month and at Muirhead Church on the other Sundays in the month. On the last Sunday of the month the congregation from Auchterhouse Church also join the service. Services are livestreamed on Zoom. There are additional services at Christmas and Easter. Holy Communion is celebrated three times a year in Muirhead as well as on Maundy Thursday, Easter Sunday and Christmas Day.

Outreach opportunities include Soup Lunches and the Friendship Group which typically all meet once a month. Children's ministry includes Messy Church, Holiday Club and links with local primary schools.

Achievements and Performance

Achievements and performance during the year include:

- Weekly services are conducted both in church and on Zoom joint hybrid services have become the norm and are well attended.
- The Prayer Group, which is run by members from both congregations, meets regularly on Zoom.
- The successful Plant Sale and coffee morning in May.
- There was also a celebratory tea for the King's Coronation in May.
- A silent auction was held in September, an exhibition of village photographs and a film night were held in the Autumn.
- 70 shoeboxes were filled in support of the Blythswood Appeal by members of the linked churches and community.
- Christmas gifts for needy children in Angus were donated at the annual Gift Service.
- Retiring offerings at Christmas were donated to Christian Aid's Middle East Appeal.
- The church magazine continues to be issued three times a year to church members; the Christmas edition is distributed to all homes within the Parishes.

- Links continue with Dundee Congregational Church.
- Communication with members is being maintained by email for those who are online and by post/hand delivery for those who are not. The church Facebook page is used to communicate with the wider community.

- In accordance with National Guidelines and the Presbytery Plan the linked congregations are now part of the Carse and North-West Grouping. Joint activities include Songs of Praise Services, a ceilidh, Pulpit Swaps, Outdoors with God, Monthly Evening Prayer worship events, a Lent Study and a shared electronic calendar accessed through the Invergowrie Church Web page.
- Joint activities between Lundie & Muirhead, Fowlis and Liff and Auchterhouse churches include some joint services, shared activities and combined Kirk Session meetings.
- There are also joint activities, e.g., Messy Church, with Invergowrie and the Carse churches.
- Muirhead Church kitchen was extended and refurbished to improve the catering facilities.

Financial Review

The principal source of church income is offerings, comprised as follows:

During the year a few members joined the gift aid scheme and some members increased their regular giving. A £5,000 legacy was also received during the year.

Fundraising activities during the year raised £1,155 at the Plant Sale & Coffee Morning and £2,064 at the Silent Auction. Donations at the village photographs and film evening events totalled £570.

The estimated tax to be reclaimed on gift aid donations given during 2023 is £5,216.

There are sufficient funds to meet any reasonable expenditure in the short term.

The total cost in 2023 of extending and refurbishing the kitchen at Muirhead Church was £38,688. This was funded by a £15,000 donation, £3,800 gift aid reclaimed, £3,000 from the Community Council for a dishwasher, £6,133 left over from the Church refurbishment and £11,161 remaining from the sale of Lundie Church (from General Trustees).

Reserves Policy

Unrestricted Funds

It is the Trustees' policy to hold reserves of approximately three months' expenditure in the bank account. At the year end the Church held unrestricted funds totalling £42,743 of which £16,175 was designated for the Reserve Fund, £11,433 for Reserve Fund 2 (cost £7,031), £5,315 was for Future Projects and £9,820 was in the bank. £2,344 and £966 were also held by the Children's and Friendship Groups, respectively. The Reserve Funds may be required to contribute towards Fabric repairs of an old church building and the manse.

Restricted Funds

At the year end the Church also held £6,955 of restricted funds. The Flower Fund (cost £999, value £2,198) and Sunday School (cost £3,502, value £4,757). The purpose of the Flower Fund is to provide flowers for display during services of worship. The Sunday School Fund provides income for children's groups. During the year £50 was donated for flowers. There are no Endowment Funds.

REPORT OF THE INDEPENDENT EXAMINER

I report on the accounts of the charity for the year ended 31 December 2023 which are set out on pages 5 to 9.

Respective Responsibilities of Trustees and Examiner

The charity trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustees Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006.

The charity trustees consider that the audit requirement of Regulations 10(1) (d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1)(c) of the Act and to state whether particular matters have come to my attention.

Basis of Independent Examiner's Statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

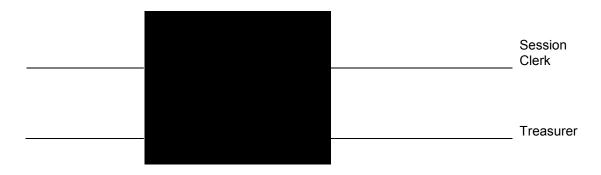

Friendship Group: To provide funds for social activities for members of the church and wider community.

Purpose of Restricted Funds

The Flower and Sunday School funds are held in investments with the Church of Scotland (see p3)

Flower Fund: This is a fund to provide flowers for display during services of worship.

Sunday School Fund: This is a fund to provide income for the Sunday School and Messy Church.

£6,133 left from the refurbishment work was held in the general bank account and then contributed to the cost of the kitchen extension and upgrade.
