


Charity Sub-committee

Objectives and activities

This charity was set up by founder	after being diagnosed with PTSD &
Obsessive-Compulsive Personality I	Disorder and ending his career from The Royal
Marines. had noticed how his o	wn dog reacted to him in moments of stress and how
much he helped him in these times.	The realisation that dogs could help other veterans
and members of the public brought the	he idea to life.

The organisation's purposes are:

- 1. The advancement of health by supporting the improvement of the mental wellbeing of armed forces veterans in Scotland
- 2. The advancement of citizenship or community development by promoting social inclusion and preventing self-isolation within the armed forces veteran community
- 3. The advancement of animal welfare through the re-homing of rescue dogs to be trained as companion/assistance dogs for veterans struggling with mental health issue.

We help provide dogs used to be trained as a mental health assistance dog by helping with the costs to purchase/adopt a dog. We also help fund the training which is provided by Oliver's Army - Dog Training - Oliver's Army Assistance and Therapy Dogs (oliversarmyassistancedogs.com)

We also run a hub in the Linton Lane Centre in Kirkcaldy every Monday night from 7pm – 9pm. In that hub we welcome all members of the community.

We also updated our constitution to allow us to train veterans that have their own dogs. We have Angus and Navy veteran going through our training programme.



Structure, governance and management

Two-tier model –

We follow the A Veterans Best Friend Constitution which all trustees have read and agreed to follow while carrying out all duties for AVBF

Trustee recruitment and appointment

Trustees have remained the same in year 4. The introduction of a subcommittee has allowed for more in-depth discussion and ideas with the board of 3 trustees having the final say on any important matters.

A lot of work was done behind the scenes to find a committee member who could provide dog training, but this was unsuccessful.

We have continued to work with Olivers Army (SCO48628) who provide Assistance and Therapy dog training this year with great success. Our board member is currently going through the process with his dog Angus, and we have an update from him later.



Achievements and performance for year 3

This has been a great year which has seen the ideals and needs of what AVBF want to achieve just fall into place

- We pay for dog insurance and medical bills for Ollie; on the 10th of December 2022 we place Ollie with veteran and after Ollie developed some skeletal issues which allows us to help the veteran financially. Further update on page?
- We continue to work with Olivers Army who will help our veterans/service users train their dogs.
- We also run a hub in the Linton Lane Centre in Kirkcaldy every Monday night from 7pm – 9pm open to all members of the community.
- In that hub we welcome all members of the community, this will help prevent isolation by getting people to socialise and get out the house.
- We have a base to work out of i.e., the Linton Lane Centre, in Kirkcaldy, Fife, KY2 6LF where we have our hub, but also it is a place to train the dogs.

Financial Review



We have no restricted funds

Income received through donations and fundraising £3215.78 and Expenses total £3906.98

We have concentrated our efforts this year on organising ourselves, getting our subcommittee set up and deciding where we want to see the charity heading.

In year 4 there has been no travel costs and an increase in the training expenses as our new relationship with Olivers Army hopefully we can now offer more and more training to any veterans who come to us.

Next year we will report on our fundraiser and the donation by the Air Cadets who have donated funds but were out with this reporting period.

AVBF Reserves Policy

A Veterans Best Friend (AVBF) shall be a wholly transparent charity. The following is a further commitment to this by means of a reserve policy.

As defined by published guidance; "Reserves are that part of a charity's unrestricted funds that are freely available to spend on any of the charity's purposes. This definition excludes restricted income funds and endowment funds, although holding such funds may affect the reserve policy. Reserves will normally also include tangible fixed assets such as land, buildings, and other assets held for the charity's use. It also excludes amounts designated for essential future spending.

In essence. AVBF funding shall be monitored by the Board of Trustees with the following guidance.

As AVBF is a start-up charity, initial funding shall be critical to enable to charity to set up and deliver services. This will mean in essence as we are searching for funds and supporters that it is imperative to invest as much as possible in as expedient a time as possible. The following policies shall apply:

Unrestricted funds - to be used in all relevant areas throughout the charity.

Restricted funds - to be used only in conjunction with the funder's specific instructions.

While prudent to have a reserves policy; it is also realistic to acknowledge that there will be little ability to keep much in reserve when the charity is starting from zero and looking to get off the ground so it is proposed that the reserves policy shall be amended and updated as funds continue to grow. Initially, the reserves policy shall be set at 5% of unrestricted funds in Year 1 hoping to increase this to 10% Year 2 and thereafter. Obviously, there is no reserve element to restricted funds as those funds are given for a specific element and shall be used for such.

As per the Charity's Constitution, the Board of Trustees shall monitor and be responsible for this policy on a regular ongoing basis.

The charity bank accounts are currently healthy and we do not have any deficit. We will have an Income and Expenditure report each month going forward and any expenditure in the past has always been looked at by more than one member along with a cheque of the bank account.


Update in next year's report, Yes

Angus passed his Silver assessment on the 1st May 2024. He continues to attend classes weekly at Olivers Army training to achieve the tasks required to pass his Gold award. Olivers Army are pleased with his achievements to date.

and Luna

RAF Veteran () got in contact in September 2024 and has his own dog called Luna; he was referred to us by Oliver's Army to help with funding. He will go through the same process as and Angus; however, because Luna is only 14 weeks old, she will go through puppy foundation before starting her Kennel Club Good Citizen training.



Here is their story -

Along with my golden labrador Angus, I have been attending AVBF for almost 2 years. I have found the weekly visits have offered me an opportunity to relax in a group of likeminded and supportive veterans. We reminisce over a cuppa and there is much banter which we all agree we look forward to. Over the years since being diagnosed with PTSD I have attended other groups and sessions and have to say that I have found AVBF to have been of the most benefit. They have offered emotional support for myself and advice regarding training of Angus.

Unlike other organisations, the support provided by AVBF does not end when the group meeting is over. There is the comfort of knowing that if needed there is an ear willing to listen if required.

Approximately 16 weeks ago, on the advice of AVBF, Angus and I started to attend Olivers Army for further help with training Angus to become an assistance dog. I had a few issues with Angus, he pulled badly on lead and he could be reactive at times to other dogs. Although I did not feel he was aggressive it was a behaviour that needed to be addressed to enable Angus and myself to get the most out of each other. On our first visit with Olivers Army they suggested a gentle leader halti. This has been an absolute game changer and made walking Angus so much more pleasurable and makes it easy to control him when he sees other dogs.

The trainers at Olivers Army are very knowledgeable and helpful. They have been very patient in their training when it appeared that neither Ken nor Angus were listening and also being considerate of Kens mental health issues.

There is a noticeable improvement in Angus behaviour, especially when seeing other dogs. I was very proud when he passed his Bronze Level and was awarded his blue jacket. Olivers Army have included the AVBF logo on his ID badge and also on the tag that he wears attached to his blue jacket.

I am very grateful for the help and ongoing support from A Veterans Best Friend who provide the finance for Olivers Army and we would hope to look forward to a long and mutually beneficial relationship going forward.

Future plans

We want to get the funding; therefore, it is important we get our financial return in as a lot of funders look for 12-month financial history.

Help match up at least 3 more dogs with service users in year 4

Because we are using Oliver's Army for training, we can spread ourselves wider as Oliver's Army can do training remotely.

Work alongside the Scots Guards Association to raise awareness in what we do.
