Report of the Trustees

The Trustees are pleased to present their report together with the financial statements of the church for the year ended 31 December 2024.

Status of Charity and Governing Document

Abbeygreen Free Church of Scotland is established by Constitution. It is a registered Scottish Charity (No. SC050191).

Aims and Affiliation

Abbeygreen Free Church of Scotland is a congregation of the Free Church of Scotland working towards the common aims set out below. It is a Presbyterian Church adhering in its worship and doctrine to the position of the Church of Scotland at the Reformation. The Free Church of Scotland has an explanatory document which explains the origins of the Church, and which gives the historical background to the Church coming into being in 1843 and lists documents in which is embodied the constitution of the Church. The document is available on request from the Free Church of Scotland, 15 North Bank St., The Mound, Edinburgh, EH1 2LS.

The Free Church of Scotland currently has over 100 congregations in Scotland, as well as one in London and four in North America, and sister Churches founded by mission work in India, Peru and South Africa. The Church also has a seminary in Edinburgh for the training of ministers and other Christian workers and sustains an extensive missionary programme relative to the size of the church. The principal activity of the Church is the conduct of public worship and associated matters in the context of local congregations.

Dating from 1843 but with its roots in the Reformation, the Free Church of Scotland owes its distinctive title to its historical struggle to remain 'free' from state interference in its internal affairs. It has close and active relations with many other Reformed churches of Jesus Christ throughout the world and stands firmly in the tradition which accepts the Bible in its entirety as the Word of God and, therefore, derives its forms of teaching, worship, ministry and government from it. The main emphasis of our worship is the preaching of the gospel - the good news of a free and sovereign salvation through Jesus Christ alone.

The congregation is authorised by the Church to have a minister paid from central funds of the Church.

The church sanctuary, halls and manse which are occupied by Abbeygreen Free Church of Scotland, are made available by Abbeygreen Ministries Trust (Scottish Charity SC049960) via a lease agreement.

Trustees and Office Bearers


The congregation is governed and administered by elected office bearers (all volunteers) and its minister. The Kirk Session, being the minister and elected elders, has responsibility for spiritual oversight, while the Finance Committee, composed of Kirk

Session members plus elected supplementary members, oversees financial and property matters. Under Charity Law, the Finance Committee are deemed to be the trustees of the congregation as those with responsibility for day-to-day management and control. This is distinct from the role of property (congregational) trustees who are responsible only for holding property in trust.

The Rev David Carmichael retired at the end of January 2023 after a distinguished, fruitful and much blessed ministry of over 40 years. The post of minister has remained vacant since then. The Free Church appointed the Rev Norman Mackay as Interim Moderator, who has been supporting the Kirk Session and Congregation during this time of vacancy and a Vacancy Committee is now overseeing the search for a new minister.

The members of the **Kirk Session** (the Trustees) and the **Finance Committee** (elected members) who served during the year were as follows: -

Kirk Session



Appointment of Charity Trustees

The Kirk Session exercises its discretion in determining the most appropriate method of electing new Trustees (Elders and Finance Committee Members). Any election process must involve the communicant membership of the congregation. There is no fixed term for Trusteeship. Prior to their appointment, new Trustees would have served the Church for some time in various roles and would be familiar with the Church's values, its aims and objectives as well as its day-to-day operations. As part of their induction programme, new Trustees are required to understand their statutory responsibilities as well as the responsibilities of their office within the congregation as elder or Finance Committee Member. The previous minister, stepped down from the Kirk Session following his retirement at the end of January 2023.

Activities and Achievements

During the year, the congregation met regularly for public worship and carried out various activities in pursuit of the above stated aims. The congregation continued its commitment to support the Free Church of Scotland denomination both spiritually and financially. Highlights, events and developments of note in the year include the following:

Church Organisations

The nurture of our children and young people in the Christian faith is vital to the health and future of our church and is much covered in prayer by our congregation.

Our crèche provides care for several infants, allowing parents to attend morning worship. Our Sunday School, (for ages 3 - P7) is in a healthy condition, and we also have a good Bible Class (S1 & S2). These groups met on a weekly basis to offer Christian Education to children of all ages and focus on the same Bible teaching each week, at an age-appropriate level, to help their Christian development. Each month our children learn a new "hymn of the month" – usually an older Christian Hymn – to help maintain the connection between the worship which takes place in our Sunday School and in the Church service.

The Youth Fellowship (14 and over) is very well attended and provides a structured programme of in-depth Bible study and teaching, as well as promoting fellowship and friendship among our young people. It continues to be full of very fine young people who are a credit to themselves, their families and our church and it is a group that contributes much to the life of our congregation. The Youth Fellowship enjoys good leadership from a leading elder and his wife, and an excellent committee of Christian young people.

The Girls' Brigade takes place on Tuesday evenings for girls from Primary 1 to Secondary 6, with the older girls having opportunities of leadership training and service to church and community. The Girls' Brigade is a worldwide Christian organisation for girls and women whose aim it is to help and encourage girls to a Christian commitment. Girls' Brigade is very often the only contact that some girls have with the Church, which

provides opportunities to make contact with the wider family through special events and services, all of these opening up avenues to reach young people for Christ.

Our Choir continues to lead our congregation in song, with a blend of young and mature voices, supporting the worship of our congregation on a week-by-week basis.

Our weekly ladies Bible study groups provide several opportunities during the course of a week for Bible study and prayer. These groups are well attended and a great encouragement to the women in our congregation.

The Tuesday Fellowship meets each Tuesday morning and provides opportunity for fellowship to those available during daytime. This is an informal gathering with chat over tea and coffee and the showing of a short devotional video towards the end of the meeting. The Tuesday Fellowship has proven to be popular and greatly appreciated by those who are able to attend.

Each of these organisations benefits from fine leadership of a most committed kind. The Kirk Session exercises oversight of all of our organisations, with many of our Elders playing an important, vital and active role in many of these groups.

Outreach

Special events are regularly organised to reach out to people in our community with an invitation to come and join in the fellowship life of our church. The Ark, our very popular Mother and Toddlers Group, continues to prove attractive to parents in our village evidenced by the fact that there is a waiting list for membership. The Ark meets important community needs and there is nothing quite like it in the village. While similar local groups seem to struggle for survival, the Ark continues to flourish. We know that it enjoys the informal support and commendation of local midwives.

The Youth Club continues to play a vital outreach role to the children of our village and has seen good numbers continuing to attend throughout the year. It continues to be run by a group of committed Christian volunteer leaders and led by two of our elders.

Our annual Summer Club is always a popular event in the life of our community. Each year it draws amazingly large numbers of children every night of the week that precedes the recommencing of school after the summer break. It remains a fact that the experience of our Summer Club has become a rite of passage for many children in our village with former attendees now being parents themselves who bring or send their own children to the Club. The Summer Club has a leadership and volunteer team that numbers approximately 60 people in size, led by three of our elders, and is a major event in the life of our church.

The Elders Christmas quiz night takes place each December and allows members of the congregation to invite their friends and family to an evening where they can have fun with a first-class general knowledge multimedia quiz, enjoy a fantastic supper while also having the opportunity to listen to a Christmas Gospel message from an invited speaker.

Our congregation continues to support several external Christian organisations. Our former minister, remains a member of the congregation as minister emeritus and continues as Chair of the Scottish Reformed Conference, held annually at Hamilton College School in May. Approximately 500 Christians from all around Scotland gather to hear the preaching of God's word from two nationally or internationally renowned speakers, as well as enjoying evangelical Christian fellowship. The organising of this conference is largely supported by members of the Abbeygreen congregation. We continue to support the work of the missionary organisation UFM Worldwide. In particular, we support two missionaries in France and Spain as well as supporting and helping the organisation of the UFM Scottish Rally held in April each year.

As always, we remain thankful to God that we continue to enjoy the supply of spiritually keen people who are always ready and willing to volunteer to give service to our Lord and his church. This is in response to the committed and faithful preaching of the Word of God, which nurtures our faith, promotes fellowship, encourages service and inspires and directs our evangelistic outreach efforts. We also remain committed to promoting the practice of individual and collective prayer, believing that God answers the prayers of his people in accordance with his sovereign purposes. We can testify that as we have sought to be a faithful people, the Lord has once again met all of our spiritual and temporal needs. As a congregation we count it a privilege to live under the directing rule and blessing of God, and we are thankful to Him for His provision.

Financial Review

Results for the year

We have made a deficit of £7,949 in this year – this is £5,779 for the General Fund and £2,170 for the organisations. As a result of this deficit, the church held unrestricted funds amounting to £135,576 at the year end. That consisted of a General Fund amounting to £129,351 and Designated Funds with a balance of £6,225. Small additional funds were held at the year-end for 3^{rd} parties – these amounted to £127.

Ministry costs have increased this year, mainly because we have now paid a full year of mission levy costs to FCoS, totalling £35.2k — this is calculated based on our income level. Whilst vacant, we have continued to pay the fixed ministry costs to FCoS as well as paying for Pulpit Supply for Sunday Services, morning and evening, and some midweek services, although in 2025 we will see that drop with FCoS permitting us to claim back pulpit supply costs for Sunday services. Other Building Costs increased, with increased focus on repairs for both Church and Manse buildings. This included works such as stonemasonry, roofing, plastering, painting and electrical. Other Expenses have increased, with increased support for mission work from the Midweek, and from the Church for TSCTV.

The Trustees are satisfied with the levels of reserves retained, noting that known expenditure can be covered with additional monies held for forward planning.

Report of the Independent Examiners to the Trustees

for the year ended 31 December 2024

I report on the accounts of the church for the year ended 31 December 2024 which are set out on pages 10 to 15.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006. The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiner's statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts and seeks explanations from the trustees concerning such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

Accounting Policies

Accounting Convention

The financial statements have been prepared under the historical cost convention, and in accordance with the Free Church Guidance.

Basis of financial statements

The financial statements have been prepared on a receipts and payments basis.

Receipts and Payments account

Restricted funds compirse income which has been received for the objects of the church and specified for a restricted purpose within these objects by the donor. Unrestricted funds comprise al income received for the objects of the church without further specified purpose and are available as general funds Designated funds comprise income specified by the trustees for a particular purpose, within the stated charitable objectives of the church. For the purpose of the Receipts and Payments account as shown on page 11, funds are defined as follows: Abbeygreen Free Church of Scotland does not currently hold Restricted Funds.
