Structure, Governance & Management

Governing Document:

j8 Educational Partnership is a single tier Scottish Charitable Incorporated Organisation (SCIO) which was granted charitable status on 8th April 2015 and is governed by its constitution.

Trustee Recruitment & Appointment:

At each AGM, all of the charity trustees must retire from office - but may then be re-elected under clause 27. A charity trustee retiring at an AGM will be deemed to have been re-elected unless: -

- 1.1 he/she/it advises the Board prior to the conclusion of the AGM that he/she/it does not wish to be re-appointed as a charity trustee; or
- 1.2 an election process was held at the AGM and he/she/it was not among those elected/re-elected through that process; or
- 1.3 a resolution under sub-clauses 28.5, 28.6, 28.7, 28.8 was put to the AGM and was carried.

Objectives & Activities

The Charities Charitable Purpose:

As set out in the 'Constitution' and 'The Charities and Trustee Investments (Scotland) Act 2005' the purpose(s) of j8 Educational Partnerships SCIO are the following: -

- The advancement of education

Any other purpose that may reasonably be regarded as analogous to any of the preceding purposes.

Summary of the main activities in relation to these objectives:

To advance education through research by school pupils into the barriers to education within specific communities in the developing world, additionally to research solutions and to then take appropriate action to reduce these barriers.

Achievement & Performance for 2026

j8 Educational Partnership's charitable purpose is the advancement of education, initially through research by school students within specific communities into the local barriers to education, and their solutions, so that appropriate action can be taken to reduce these barriers. j8 links schools in the UK with schools in other countries in order that they can work in partnership to increase the opportunities for education in both communities.

ACTIVITIES, ACHIEVEMENTS & DIFFICULTIES 2025/26

1. Each year we lose many of the primary schools because their teachers are given a different yeargroup or because the link faces severe practical difficulties, but we were able to set up new replacement literacy links with several PS in Scotland, Malawi and the island of Antigua in the Eastern Caribbean as well as continuing the links with some of the existing PS.
2. The secondary students took part in fundraising activities, including the making and selling of Christmas wreaths, sold at the schools' Christmas Fayres.

Achievement & Performance cont'd

3. Literacy links were started in 2021, as improved literacy was identified as a significant way of increasing the attainment of the children in all the schools, and increasing their interest levels. The Scottish teachers and their pupils are all very enthusiastic about these links. The pupils quickly regard their overseas partners as friends, on an equal basis and the links do much to advance global citizenship. Their economic poverty does not enter their thinking, unlike for the secondary school activities where it is front and centre. The Malawi schools are equally keen but face difficulties in sending letters and printing those received. Many of the teachers' phones, crucial to the exchange of letters, are unreliable and the teachers rarely have the disposable income to fix them or buy new ones. These problems appear to be increasing year on year.

FINANCES 2025/26

The secondary students have been involved in a little fund-raising this year at Christmas time. No external funding has been obtained, nor have there been any donations. Parents in Malawi find it increasingly difficult to afford school fees and, more than ever before, schools are asking j8 for help with buying phones, printers and stationery. We already pay for reading books for all the participating pupils and the cost of printing our letters. Two Malawi schools dropped out because the teachers' phones were broken and one other school had to involve another member of staff because of the same issue. It is, unfortunately, not possible financially to pay for phones for all the schools involved.

Financial Review

Statement of Reserves Policy:

The reserves at the end of the year were £10,050.64 (2024: £10,710.40). The charity has no employees or buildings which has meant that the trustees have decided that no formal reserves policy is in place, however, the trustees will continue to monitor as the charity grows.

Investment Policy:

The trustees have a duty to seek out suitable sources of income generation. The trustees also consider that it is prudent to accumulate funds for reserves to carry out the charity's aims and meet their annual obligations for Student fees.

The Trustees have the power to invest funds in the best interest of the charity. To meet these ends the Trustees have invested in a deposit savings account with Virgin Money which accumulates interest to increase the current reserves.

Details of any deficit:

There was a financial deficit this year, the Trustees will continue to monitor the balances going forward.

Details of Donated Facilities & Services:

The Charity benefits from the time given by all the Trustees to the running of the Charity.

Statement of Trustees Responsibilities

The members of the Charity must prepare financial statements which give sufficient detail to enable an appreciation of the transactions of the Charity during the financial year. The members of the Charity are responsible for keeping proper accounting records which, on request, must reflect the financial position of the Charity at that time. This must be done to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006.

They are also responsible for safeguarding the assets of the Charity and must take reasonable steps for the prevention and/or detection of fraud and other irregularities.
