Background and Constitution

The Association's constitution was adopted on 10th December 2001.

Activities commenced on 1st January 2002

The Association has charitable status. The charity reference number is SC032518.

Because of this charitable status, there is no liability to income tax on any financial surplus generated.

Control

The policy and general management of the Association are directed by a Committee of six members elected at General Meetings to serve for three years. Each year one third of the Committee is required to retire by rotation but is eligible for re-election.

Objectives and Activities

The purposes of the Association are the provision of voluntary unpaid services in furtherance of the wellbeing and comfort of the patients and staff at, and visitors to Biggart Hospital, Prestwick. From the surplus funds generated by these activities, the Association may make grants to the endowment funds held by hospital managers for the purpose of enhancing the accommodation or facilities, or for the purchase of equipment, machinery, instruments, fittings and fixtures or furnishings to be used at Biggart Hospital or its associated clinics.

Following a COVID break the operation recommenced activities on 1st October 2022.

The accounts for the year to 31st March 2026 have shown a deficit of £3,113 from ordinary activities. Gifts to the value of £9,069 have been made in the year.

The Association plans fully recommence its customary activities in the year ahead in accordance with its purposes. Discussions will progress with the hospital authorities to determine the uses to which the accumulated surplus as at 31st March 2026 will be committed.

Committee Responsibilities

Legislation requires the Committee to prepare Financial Statements for each year which give a true and fair view of the state of affairs of the Association and of the surplus or deficit for that period.

In preparing those financial statements the Committee is required to:-
select suitable accounting policies and then apply them consistently;
make judgements and estimates that are reasonable and prudent;
state whether applicable accounting standards have been followed,
subject to any material departures disclosed and explained in the
Financial Statements.

The Committee is responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the Association and to enable it to ensure that the Financial Statements comply with legislation. The Committee is also responsible for safeguarding the assets of the Association and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

I report on the accounts for the year to 31st March 2026 which are set out on pages 6 - 9
