**Appointment of Trustees**

All of the Church's trustees are elected by the membership to serve for a period of 5 years.

**Governing Document**

The Church is a Scottish Charitable Incorporated Organisation (SCIO), and the purposes and administration arrangements are set out in our constitution.

**Charitable purposes**

The Purposes are the advancement of religion, specifically the Christian faith, primarily in Buckhaven and neighbouring parts of Fife, and also throughout Scotland and the rest of the world, by all means consistent with:

The Christian Bible; and

The Declaration of Principle;

including, without prejudice to the foregoing generality, worship, ministry, mission, witness, prayer, fellowship, networking, education, community service and the provision of activities and facilities for the community, and the relief of poverty and other social needs, including the support of individuals and other charitable organisations and agencies involved in any or all of these.

**Activities & Achievements**

Our Pastor, Ian Llewelyn has served the fellowship just short of 2 years and has been faithful in proclaiming the word.

The Wednesday prayer meeting now named 'Prayer Gathering' has included a time of Bible Study. We have been encouraged by the numbers attending and the warmth of fellowship.

The Cosy Café (formerly called the Safe Haven Café) continued to have an impact on the community, meeting on Wednesdays from 10.00am until noon when refreshments are served after which meals are served for approx.1 hour.

A food distribution programme runs alongside the Café. Robert Scott takes charge over the food distribution and overseeing the café. We have seen a large increase in the number of clients requiring help.

We were again able to hold a Harvest Service with material sent from the Baptist Missionary Society, and an offering was sent for this cause.

A Christmas gift was collected for Children's Hospice Association of Scotland at Rachel House, Kinross.

By way of outreach, a BBQ was held in August with a good attendance.

The hall has been used well for community use, having hosted a table tennis club, the Fife "0" gauge Group (model trains), and Primary School special classes.

Sunday Morning worship saw an international flavour with a Nigerian family and a young Iranian joining us on a weekly basis.

We are very grateful for the Grant donations we have received towards the cost of the food etc. for distribution to those requiring help during this Cost-of-Living Crisis, from Fife Voluntary Action.

Our prayer for 2025 is that the Lord will bring in families which in turn will revive the Children and Youth work, in which the Church has shown strength in past days.

### **Reserves**

The Church held Unrestricted Funds of £66,415.94 at the year end. The Trustees consider that the General Fund of £35,730.43 will enable us to continue to run the Church for the forthcoming year.

### **The Baptist Pension Scheme (BPS)**

The DB Plan has now been Wound Up and with effect from 16 March 2024 the Church Trustees retained no further liability nor any future funding responsibility for the Defined Benefit section of the Baptist Pension Scheme.

### **Scottish Charitable Incorporated Organisation (SCIO)**

During this Financial Year there was a change of legal form in which the Church became a Scottish Charitable Incorporated Organisation. This status was granted on 9 January 2024, and the Church became known as Buckhaven Baptist Church SCIO (SC053047)

All assets were transferred from Buckhaven Baptist Church (SC006862) to the new Charity on 31 March 2024, although it took until 26 June 2024 for new Bank Accounts to be finally set up and all funds transferred to the new accounts. The Charity (SC006862) was wound up on 18 July 2024

### **Benefits of a SCIO**

A SCIO provides personality and protection. The SCIO as an incorporated entity is a legal person, which can hold property, enter contracts, undertake loans and other obligations and sue and be sued. The SCIO has the benefit of limited liability. The assets, funds and property of the SCIO can be targeted by litigants and claimants, but trustees are sheltered under the canopy of the SCIO and are no longer in the immediate firing line if these assets should prove to be insufficient.

Charity trustees still of course have legal duties, and re-constituting as a SCIO does not give trustees carte blanche to do as they please. However, personal liability would generally be restricted to cases of gross negligence, recklessness, illegal activity or acting contrary to charitable purposes.

A SCIO is also exempt from the requirements of the Register of Persons holding Controlled Interests in Land (or RoCI for short)

**Independent Examiner's Report to the Trustees of Buckhaven Baptist Church SCIO,  
Registered Charity Number SC053047.**

I report on the financial statements of Buckhaven Baptist Church SCIO ("the Church") for the year ended 31 December 2024 which are set out on pages 4 to 15.

**Respective responsibilities of Trustees and Examiner**

The Church's Trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 ("the 2005 Act") and the Charities Accounts (Scotland) Regulations 2006 (as amended) ("the 2006 Regulations"). The Church's Trustees consider that the audit requirement of Regulation 10(1)(d) of the 2006 Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1)(c) of the 2005 Act and to state whether particular matters have come to my attention.

**Basis of Independent Examiner's Statement**

My examination is carried out in accordance with Regulation 11 of the 2006 Regulations. An examination includes a review of the accounting records kept by the Church and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts and seeks explanations from the Trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

**Independent Examiner's Statement**

In the course of my examination, no matter has come to my attention: -

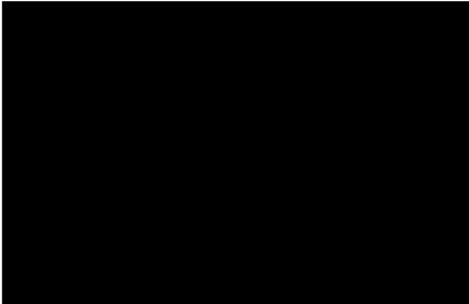
(1) which gives me reasonable cause to believe that, in any material respect, the requirements

### Notes to the Accounts for the year ended 31<sup>st</sup> December 2024

#### Nature and Purpose of Funds

##### Unrestricted Funds

General Fund - through which the day-to-day income and running expenses of the Church are recorded.

##### Designated Funds

These are unrestricted funds set aside by the Church for specific purposes and projects.

Missionary Fund – for receipt and disbursement of monies designated for missionary work.

Fellowship Fund –for the benefit of any member of the fellowship in need or having a special occasion, to receive monies donated for floral decoration of the Church, etc. or other purposes at the discretion of the Deacons.

Reserve & Fabric Fund – for repairs and maintenance of Church & Manse buildings and equipment

Manse Letting Fund – for receipt and disbursement of monies received from letting out the Manse. Part of income is to be used towards the Pastor's stipend and the remainder for the upkeep of the Manse.

Outreach Fund (formerly Messy Church Fund) – for receipt and disbursement of monies for outreach projects.

Cosy Café Fund (formerly Safe Haven Café Fund) – for receipt of income and payment of expenses involved in the provision of food and friendship to members of the local community, particularly those who are in food poverty, and specifically again this year in response to the Cost-of-Living Crisis.

Hugh Fraser Foundation Fund –for receipt of Grant received from the Foundation, for expenses incurred in the purchase and disbursement of food etc., through the Food Bank.

Jeffrey Charitable Trust Fund –for receipt of Grant received from the Trust, for expenses incurred in the purchase and disbursement of food etc., through the Food Bank.

Volunteer Support Fund – for receipt of, and disbursement of, Funding for Volunteer expenses.

Renew Wellbeing Café Fund – for receipt of, and disbursement of, donations received for setting up 'Renew Wellbeing' Café.

Maintenance of the Ministry Fund –for the management of monies received towards the costs of maintenance of the Ministry.

Fife Voluntary Action (FVA) Fund – New Fund for receipt of Grant received from the FVA, for expenses incurred in the purchase and disbursement of food etc., through the Food Bank.

**Trustee remuneration and expenses**

Ian Llewelyn is employed as Minister (part-time) of the Church and, as so, received a Net Stipend amounting to £12,051.36 over the Financial Year. He also received Travel Expenses (at 45p per mile) amounting to £65.70 and the Church paid Employers Pension Contributions of £1314.96.

No other remuneration or expenses were paid to the Trustees this year.
