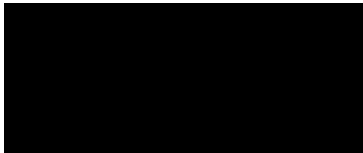

Mrs A S Butler Trust SCIO was established on 8 August 2019 and is a Scottish Charitable Incorporated Organisation (SCIO). It was established to take on assets from Mrs A S Butler's Trust (Scottish Charity number SC003401), however, no transfer has yet taken place and the SCIO remains dormant.
