- I. Preservation, cataloguing and scanning of historical documents with a view to online accessibility.
- m. The refurbishment of lounges and corridors to improve the awareness of the club's history.
- n. Continued involvement with McCrae's Battalion Trust including representation at the annual Remembrance event at Haymarket.
- o. Monthly meetings of Football Memories groups to support older people living with dementia and other memory problems.
- p. Delivering talks to community groups on the work of the Trust and the history of the club.
