**Independent Examiner's Report to the Trustees of Forth Childrens Theatre SCIO

I report on the accounts of the charity for the year 16 May 2024 to 31 October 2025.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities

Basis of independent examiner's statement
