- 5. To provide all its services in a way that is fair to everyone.

# Summary of the main activities in relation to these objects

The main activities during the year were as follows:

- 1. Running of Senior Men, Senior Women and Under 18, Under 16, Under 14, Under 12, Under 10 and Under 8 Boys and Girls teams.
- 2. Supporting coaches and officials with further education opportunities.

## Achievements and performance

# Summary of the main achievements of the charity during the financial period

Season 23/24 was a great success for our SBC National League teams, as our U14 girls won their league undefeated and our U16 girls represented well as they reached Final 4s of the SBC league.

The club also performed well at all regional competitions, giving opportunities to play for many age groups for both boys and girls. Again this year we have several girls within the Scottish national squad.

Membership numbers increased to the region of 160 registered youth players over the season, as well as our senior men and ladies groups continuing to grow. We also introduced Over-40 Masters basketball this season, with our eldest player being 76 years old.

Challenges continue to be venue and travel costs and availability. A number of venue condition issues have limited our participation at times throughout the season. As a club we have managed to navigate these issues by combining sessions, etc, however venue conditions continue to be variable and basketball equipment unreliable at times. We continue to raise funds to support player costs and make access to basketball as affordable as possible.

Club initiatives such as developing school basketball and officials have been successful. Bears ran a primary schools tournament under their own "ELEVATE" banner. This provided opportunities for non-club players to play competitive and inclusive basketball without the need to fully commit to a club structure.

Volunteer numbers remain healthy, with a number of parent groups assisting our volunteer coaches with sessions and travel.

Overall, season 23/24 can be deemed as successful in terms growing the game in the Highlands.
