Objectives and activities

Charitable purposes

Kenyawi Kids objects are:

- The prevention or relief of poverty by promoting self-sustainability in relation to orphan care in Malawi.
- b) The relief of those in need by reason of age, ill health, disability, financial hardship or other disadvantage. Kenyawi Kids work will benefit orphans in Malawi though projects involving farming and education.
- c) The advancement of education through agriculture education and the promotion of selfsustainability through projects that will teach children key life skills.
- d) The advancement of citizenship or community development. There are a variety of ways in which this can be done, including purchasing farm land for the orphanages and carrying out training programmes within local communities in order to promote a self-sufficient living.

Summary of the main activities in relation to these objects

Kenyawi Kids have distributed funding to our partners STEKA, Chimembe Orphan Care and Catch the Fish Foundation. We entered into discussion on the closure of Chembe Water Project as a new company are setting up in Chembe Village and we are in full support of community ownership and buy in. This is likely to conclude in June 2024. In April 2023 we supported the establishment of Mayamiko, a new childcare centre in Limbe, Blantyre, Malawi and we are delighted that 30 children are now safe and secure.

Achievements and performance

Summary of the main achievements of the charity during the financial period In April 2023 the founding Director of Yamikani House returned to the home and after raising welfare concerns for the 24 children who resided there, it was decided by Social Welfare that the children were to be removed from the home, along with our financial support. We were able to work with former Director of Yamikani House to relocate the children to Mayamiko House in Limbe, 20 minutes from the original home. The children are thriving in the new home and it is our intention to fundraise the £90,000 to allow the purchase of the land and home to ensure a safe and secure future for the children and future children who require long term and emergency shelter. Kenyawi Kids have single handedly funded Chembe Water Project for 10 years now and we are delighted that a new partner is able to take it over, allowing our funds to be disbursed to our orphan care partners in Malawi. STEKA house now houses 97 children and we were able to fully fund their staple food budget this year. We remain grateful to our existing donors and remain committed to finding sustainable approaches to orphan care for the 150 children we support in Malawi.
