The Trustees present their report together with financial statements for the year ended 30 September 2024.


Constitution and management

The Society is operated under the rules of its Constitution dated June 2003 and is registered as a Charity with the Office of the Scottish Charities Regulator (OSCR).

The management of the Society is the responsibility of the Committee under the terms of the Constitution. The Constitution states that the Committee shall comprise The President, Vice-President, Secretary, Treasurer and six ordinary members to be elected at the Annual General Meeting to serve for a period of two years in such a manner that two ordinary members shall retire each year.

Trustees

Objectives and activities

Leitheatre is a community based amateur theatre group, drawing its members from all over Edinburgh, but particularly from the north of the city.

Leitheatre presented three major productions during the year ended 30 September 2024: "The Prime of Miss Jean Brodie" and "Blue Remembered Hills" in the Church Hill Theatre in November 23 and May 24 respectively and "Stepping Out" on the Edinburgh Festival Fringe 2024 at Inverleith St Serf's Church Hall. The November production and the Fringe show were very well attended and made a good surplus, whilst the May show made a loss.

Leitheatre also entered one play in the SCDA One Act Play Festival – "MOT", which was placed 3rd at the Edinburgh District round and went through to the next round where it was not placed. It did, however, win the award for the best staging.

Review of the financial statements

The bank balance at 30 September 2024 was £23,050 compared to £23,953 at 30 September 2023.

The Committee is satisfied that the balance of the Reserve Fund of £27,277 is sufficient to meet three months of operating expenditure, taking into account the anticipated income and expenditure for the Autumn production of "Dancing at Lughnasa" and the ongoing maintenance of the building.

Trustees' responsibilities for the financial statements

INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES OF LEITHEATRE

For the year ended 30 September 2024

I report on the accounts of Leitheatre for the year ended 30 September 2022, which are set out on pages 5 and 6.
