We are pleased at this time to be receiving applications from new clubs who would like to join the League. Expanding the League is one of our aims.

## Challenges

The SFA Comet system is still proving to be a challenge, and this has impaired our ability to operate effectively within the PVG scheme.

On account of this, we have made the decision to 'pause' League matches from August 2026 until this has been resolved.

We expect a return to League action as soon as possible.

We encountered our first serious discipline issue this year involving three clubs.

Following a disciplinary process, sanctions were applied with all three clubs accepting that they were in breach of conduct.
