## **Rainbow Valley**

Report of the Trustees for the period ended 31 January 2025.

The Trustees are pleased to present their report together with the financial statements of Rainbow Valley for the period ended 31 January 2025.

The legal and administration information on page one forms a part of this report.

### **Objectives and Activities.**

Rainbow Valley was founded in July 2012 in memory of [REDACTED], who was diagnosed with leukaemia at the age of 16 and sadly lost her battle in 2005. The charity was established by [REDACTED] alongside other family members, inspired by Johanna's vision of a holistic approach to living with and overcoming cancer.

The primary aim of Rainbow Valley is to empower individuals affected by cancer by providing them with practical tools and education to take control of their health and well-being. The charity offers a range of courses and support services that address the psychological, emotional, and physical needs of both individuals diagnosed with cancer and their support networks. The mission of Rainbow Valley is to nourish the mind, body, and soul of those affected by cancer, enabling them to take an active role in their journey towards recovery.

### **Mission for 2025**

#### **Purpose**

Educating people to take control of their cancer diagnosis by accessing new ways to thrive and survive. Ensuring everyone affected by cancer can access information on how to nurture themselves by embracing a holistic approach to their health.

#### **Mission**

To empower people affected by cancer to nourish their mind body & soul and take responsibility for their health.

#### **Vision**

That every person affected by cancer is given the tools for integrated physical, emotional and spiritual wellbeing

## **ACHIEVEMENTS AND PERFORMANCE**

During this financial year, Rainbow Valley successfully organised and executed several key events that served as the major sources of income for the charity:

1. **Brave to Bare Event:** This empowering event encouraged women, including our ambassadors, previous course attendees, and others affected by cancer, to share their experiences and support each other. This event not only provided emotional support but also raised significant funds for the charity.
2. **Rainbow Valley Fashion Show:** A special event where fashion meets compassion. This event not only celebrates the latest trends on the runway, but the incredible strength and resilience of our models, each of whom has a personal connection to cancer.
3. **Rainbow Valley Annual Charity Ball:** Attended by over 400 supporters, ambassadors, course attendees, and suppliers, this event was a highlight of the year, fostering community spirit and raising awareness of the charity's achievements and future goals.
4. **Rainbow Valley Annual Christmas Concert:** This year's event brought together over 200 supporters and performers, contributing to fundraising efforts and promoting the charity's free courses for those affected by cancer.

In addition to these main events, Rainbow Valley supporters held several other fundraising activities, including Bingo Night, Thrift Event & we worked with Local Secondary School Douglas Academy with their YPS project. The funds raised through these efforts were instrumental in delivering the Rainbow Valley mindfulness and well-being 1-day courses, which supported over 30 individuals throughout the year.

The charity reintroduced its 2-day residential courses as committed to in the last annual report and have successfully held 8 residential courses supporting 100 individuals, our courses consist of Mindfulness and Relaxation Techniques, Nutrition and Well-Being, Emotional Resilience and Support, Holistic Therapies and much more.

### **Financial Review**

Rainbow Valley operates as a non-profit charity, with a focus on maximising the impact of every donation received. In this financial year, the charity saw a 43.8% increase in receipts and donations (£244,353 vs £169,884) compared to the previous financial year. This growth can be attributed to the resumption of events and increased community engagement post-pandemic.

The charity also experienced a positive decrease in costs (£95,040 against £134,139 last year) in this financial year when compared to the previous year, due to

integrating a more cost-conscious culture and focussing on maximising the contributions from donations.

As the charity moves forward, there will be a continued emphasis on increasing donations while carefully managing costs.

### **Structure, Governance and Management**

Rainbow Valley is registered as a Scottish Charitable Incorporated Organisation (SCIO) with the Office of the Scottish Charity Regulator (OSCR), under Charity Number SC043315. The charity operates from its Milngavie office, where two part-time permanent employees manage the day-to-day activities and events.

The governance of Rainbow Valley is overseen by a dedicated Board of Trustees, who are responsible for safeguarding the charity's assets and reputation. The Board regularly evaluates and appoints additional trustees to ensure that the charity's mission and objectives are upheld.


#### **Provision of Pension Contributions:**

We plan to significantly increase the availability of these courses, ensuring

that more people can benefit from the comprehensive care and empowerment they offer.

- In addition to expanding our residential courses, we are excited to expand the number of nutritional courses which were first introduced in 2024. This program was carefully developed to provide participants with tailored nutritional guidance, helping them to strengthen their bodies and enhance their overall well-being during and after cancer treatment. Nutrition plays a critical role in healing, and we aim to continue to equip individuals with the knowledge and tools they need to make informed choices about their diet and health.
- Rainbow Valley is also dedicated to enhancing our outreach programs, ensuring that our services are accessible to a wider audience, including those in underserved communities. By increasing our presence and visibility, we aim to raise greater awareness of the resources we offer and connect with more individuals who could benefit from our support.
- Our fundraising events have been a cornerstone of our success, and we plan to build on this foundation by introducing new and innovative events, as well as expanding existing ones. These efforts will not only raise the necessary funds to sustain our programs but will also foster a sense of community and shared purpose among our supporters.
- The Board of Trustees will continue to work closely with our dedicated staff and volunteers, ensuring that Rainbow Valley remains responsive to the needs of those we serve. Together, we are committed to maintaining the highest standards of care and support, enabling Rainbow Valley to be a beacon of hope and strength for all who are touched by cancer.


#### **Trustees Declaration**

#### **FOR THE PERIOD ENDED 31 JANUARY 2025**

I report on the accounts of the charity for the period ended 31 January 2025, which are set out on pages 10 - 15.

#### **Respective responsibilities of trustees and examiner**

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Act (Scotland) Regulations 2006. 

## **NOTES TO THE ACCOUNTS**

### **FOR THE PERIOD ENDED 31 JANUARY 2025**

#### **1. Accounting policies**

##### **a) Basis of Preparation**

These accounts have been prepared on the receipts and payments basis in accordance with the Charities & Trustee Investment (Scotland) Act 2005 (as amended)

##### **b) Nature and Purpose of Funds**

Unrestricted funds are those that may be used at the discretion of the Trustees in furtherance of the objects of the charity. The trustees maintain a single unrestricted fund for the day to day running of the charity.

Restricted funds may only be used for specific purposes. Restrictions arise when specified by the donor or when funds are raised for specific purposes

##### **c) Receipts**

All receipts are included in the Statement of Financial Activities on a cash basis

##### **d) Payments**

Payments are recognised on a cash basis. Payments include any Value Added Tax which cannot be fully recovered and is reported as part of the payment to which it relates:

- e) Costs of generating funds comprise the costs associated with attracting voluntary income
- f) Charitable expenditure comprises those costs incurred by the charity in the delivery of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.
- g) Governance costs include those costs associated with meeting the constitutional and statutory requirements of the charity and include the

independent examination fees and costs linked to the strategic management of the charity

- h) All costs are allocated between the expenditure categories of the Statement of Financial Activities on a basis designed to reflect the use of the resource.

**i) Tangible Fixed Assets and depreciation**

Tangible fixed assets are capitalised, including any incidental expenses of acquisition

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life:

Office equipment – 25% straight line
