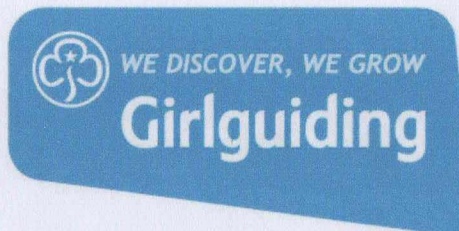

To the best of my knowledge & belief, and in accordance with the information & explanations given to me :

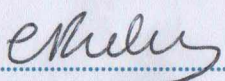
