Structure, Governance and Management

The Rhinns Playing Fields Association was incorporated as a SCIO and registered with OSCR on31 July 2019.

It is governed and managed by Trustees supported by a committee who live in the local area.

The organisation's purpose is the provision of recreational facilities, or the organisation of recreational activities with the object of improving the conditions of life for persons of all ages resident in and around the Rhinns for whom the facilities or activities are primarly intended and in furtherance of this;

. To assure the maintenance and management of the Rhinns Playing Field for sports and other outdoor activities designed to advance health and well-being. To actively promote the full use of the Rhinns Playing Fields . To collaborate with other relevant sportsclubs, youth groups, and or any other voluntary organisations to encourage the pursuit of outdoor activities: education and or assist in the provision of facilities, in the interests of social welfare and recreation.

. To own, lease, take on feu or otherwise aquire lands, buildings for the carrying out of said other objects.

. To aquire such moveable plant or equipment as are required for the carrying out of said other objects.

Achievements and Performance

In 23/24 the primary focus was to raise funds to purchase the bike track, we had confirmation of funding from The Ardbeg All Islay Fund, the co-op and Bruichladdich Distillery.

Main Objectives for Next Year

Next year, we will purchase the bike track, so we will be focusing on preparing the ground for the track's installation.
