- Sustaining newly established churches until such time as they are ready to support themselves.
- 5. Partnering with churches looking to support new church plants.

- Annual Rooted Conference held on 28th-30th Sep 2024 that served to equip existing Churches and Christians and promote church planting within Scotland.
- Since Sep 2024 a candidate has been, and continues to be sought, to participate in a church planting residency with Rooted Churches.
- Partnerships with various international churches continue to be forged with the aim of supporting church planting efforts through Rooted Churches. These partnerships have involved support in the form of prayer, friendship, resources and the sending of people to Scotland to serve alongside us in the above endeavours.
