#### **Governing Document**

The Church was administered in accordance with the terms of the Model Deed of Constitution, with a Unitary Constitution granted by the Church of Scotland law department on 14th June, 2022.

#### Recruitment and Appointment of Trustees

Members of the Kirk Session are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The Minister, who is a member of the Kirk Session, is elected by the congregation and inducted by Presbytery.

#### **Organisational Structure**

Teams i.e Mission, Finance, Property and Social, meet five time a year, chaired by a member of the kirk session, each team consists of members gifts and skills relative to the team's function. Reports are brought to the kirk session which meets five times a year. Additional meetings may be called if required.

As Presbyteries across Scotland were being reduced in number, from 1st October 2023, our church is now a member of The Presbytery of South West Scotland. Meetings will be held four times annually, two face to face and two via zoom.

#### Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

Normal weekly religious services – Sunday worship 10 – 11am; Monthly Muddy church at 1:30pm. Baptisms; Weddings; Funerals; Holy Communion; Home and Hospital visits by Minister; Guild; Scotland's Garden Scheme – Barnweil Gardens; Annual Fête; Harvest Thanksgiving; Remembrance Service; Book of Remembrance Service; Palm Sunday, Maundy Thursday, Good Friday and Easter Services; Family Christmas Eve and Christmas Services; Joint Watchnight and Christmas Day services with Annbank Parish Church; Service in which the local Masonic Lodge participate; End of Terms School Services; Guild dedication service, Guild Week Service, World Day of Prayer service; "Souper" Sunday, Minister and Chaplain to local primary school.

A daily "Religious" message is shown on the Church Facebook page. We also post intimations on Facebook and now that we have installed WiFi we are live streaming Sunday services.

## Trustees' Annual Report (cont) Year ended 31 December 2023

#### Achievements and Performance

Normally numbers at Sunday worship and at the occasional other services are monitored approximately. We continue to provide the ordinances of religion to our congregation and parish with the assistance of various media platforms and to continue in the traditions of worship and witness of the kirk.

We have also widened our membership since posting worship services on-line and our on-line presence expands beyond this country to further afield. Equality, diversity and inclusion are topics we have in the forefront of our minds and is something we continue to explore.

We invite various organisations to come and address the congregation about their work and how we can support them.

#### Financial Review

The principal sources of income are weekly and other offerings, based on FWO, gift aid, open plate and tax recovered, shows a decrease of 15% from 2022.

Annual Church Fête; Annual Endowment

Number of Gift Aid donors – 80 (a reduction of 6)

Number of Members on Roll - 212

Our average attendance is generally approx 40. There were also approx 40 at junior church who have met, mainly outdoors since the pandemic (Muddy church).

#### Reserves Policy

It is the Trustees' policy to hold reserves of approximately six months expenditure including designated funds. At the year end the Church held unrestricted cash funds of £148,148, of which £6,517 had been designated for Fabric Fund.

The church also held £11,000 of restricted funds for the purposes specified in note two.

In addition the church is an A listed building and the trustees are mindful of the need to hold sufficient funds for unexpected expenditure.

The Erskine Hall continues to be well used by Brownies, Guides, Guild, Food Bank, One O'clock hub, Masonic lodge, local SWI and YOGA class plus any events organised by social and fund raising committee.

As a church community we continue to deliver the Food Bank, set up during the COVID pandemic, which covers the 3 villages of Annbank, Mossblown and Tarbolton. This is still regularly made use of and receives frequent referrals from South Ayrshire Council Emergency Support Line. The church was successful in acquiring funding to support families in crisis over the winter and have distributed food vouchers and fuel support to over 40 families in the 3 villages.

We continue to support our partner church in Sanga, Malawi on a regular basis and share news and prayer topics.

A joint prayer and reflection time with our members from Annbank parish church continues and these are held twice a month, alternating between Tarbolton and Annbank.

## Trustees' Annual Report (cont) Year ended 31 December 2023

One O'clock hub held one afternoon per month. This was started as a social meeting for elderly villagers following lockdown restrictions being lifted. Dominoes and other branded board games are among the activities with time to chat over tea and biscuits, and perhaps an opportunity to form new friendships.

In the summer of 2023 during the main holiday month of July, one Sunday service rather than two was held jointly with members from Annbank Parish church alternating between the two villages.

#### Accessibility

Easy access to the church is via the cemetery gates and the ramp on the west side of the church and the church back door. At the Erskine hall a portable ramp can be laid at the main entrance to assist with easy access, or via the fire door. Easy access toilet facilities are available with an early upgrade planned.

#### King's Coronation Celebration

King Charles III coronation was celebrated with a community event held in the primary school. A wide selection of stalls with games, face painting and children's entertainment were well supported. Tea and tasty bites were served by members of the congregation and were sold out very quickly so busy was the event.

#### Christmas Lights Switch - On

Christmas light switch on was another busy event with hot drinks, hot dogs and sausage rolls served by our social committee members. This was also very well supported and another quick sell out.

#### Statement of Trustees' Responsibilities

The members of the Kirk Session must prepare financial statements which give sufficient detail to enable an appreciation of the transactions of the Church during the financial year. The members of the Kirk Session are responsible for keeping proper accounting records which, on request, must reflect the financial position of the Church at that time. This must be done to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 and the Regulations Anent Congregational Finance approved by the General Assembly of the Church of Scotland in 2007. They are also responsible for safeguarding the assets of the Church and must take reasonable steps for the prevention and/or detection of fraud and other irregularities.

## Independent Examiner's Report to the Trustees of Tarbolton Parish Church

I report on the accounts of the charity for the year ended 31st December 2023 which are set out on pages 7 to 13.

#### Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006. The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

#### Basis of independent examiner's statement

An examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

#### Purposes of Funds

Fabric Fund Funds set aside for maintenance of Church Properties

Reserve Fund The trustees feel it is prudent to hold approximately 6 months' expenditure in hand.

Social Fund From time to time, social events are held to raise funds for maintenance of Church/Hall

Fabric

General Fund Day to day expenses providing Religious and Pastoral care in Parish, salaries, heating

and lighting, mission etc.

Choir Fund Purchase of music

Guild Established 98 years ago. Funds raised by Annual Subscriptions and offerings from

members, out of which speakers are reimbursed. Excess funds are usually given to

Church.

Bequest Fund For Parish welfare. Established early last century to provide poor of Parish with coal.

This, of course, is now superfluous, but the income from the fund is still used for welfare

as required.

Richmond Bequest These funds have been completely used in 2022 and 2023 for Tarmac on the path and

ground adjoining the cemetery.

Foodbank Fund When the Country went into lockdown due to Coronavirus pandemie in March 2020

members of the Tarbolton Community Council set up a helpline for anyone who was shielding at home and unable to go out for basic food shopping or to collect medicine. There was a need to have a Foodbank but in order to apply for available funds and grants any such body required to have a bank account, it was therefore agreed that the church

would assist and manage the funds.

Rev. Mandy Ralph was involved with the Foodbank, particularly in its early days; indeed the Manse garage was home to it, but a move to Annbank Church took place in 2022. A food bank hub remains in the Erskine hall and several families have received food

parcels continuously since its inception.

#### 8. Minister's Stipend

All Church of Scotland congregations contribute to the National Stipend Fund which bears the cost of all ministers' stipends and employer's contributions for National Insurance, Pension and Housing and Loan Fund. Ministers' stipends are paid in accordance with the National Stipend Scale, which is related to years of service. For the year under review the minimum stipend was £28,700 and the maximum stipend in the fifth and subsequent years £35,269

Funds were realised some 28 years ago from the sale of the Manse glebe. The proceeds are held by the Church centrally and are used annually in reduction of the Minister's stipend due by the congregation. In 2023 this reduced minister's stipend by £8,213.
