Summary of the main activities in relation to these objects

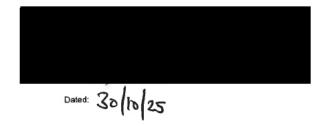
Based in Skye and Lochalsh, Counselling Care Skye & Lochalsh offers counselling to anyone in need, regardless of their circumstances. The service is discreet and totally confidential and we work to the code of ethics of COSCA (Counselling and Psychotherapy in Scotland). All of our counsellors have been professionally trained to Diploma level, having completed courses accredited either by COSCA or BACP.

FINANCIAL REVIEW
The trustees have considered the need to hold free reserves (being unrestricted funds not held as assets or for a designated purpose or otherwise committed) and actively monitor their financial position. With reference to the Statement of Balances, free reserves at 31 March 2025 stood at £95,992 (£86,983 - 2024).

The year has been a satisfactory one with a very effective team of counsellors responding effectively to a very wide range of referrals and a significant contribution from our training counsellors. The counselling team has worked well as individuals during the year, but with staff changes there has been a slight loss of cohesion and focus which needed to be picked up on.

The key change in staffing was the stepping down of one of the shared adult lead counsellors and the appointment of a replacement who has a wide experience and focused commitment to CC:SL, which bodes well for the future. As always with part time employment there can be some difficulties of responding effectively within a tight timescale. This has been responded to by the reality of a significant donation of additional hours to ensure the organisation runs effectively. I am very grateful for all the additional hours that counsellors, trainee counsellors and the Board have given during the year to make the year so successful.

Due to forward thinking the year started out on a very positive note from our funding perspective and has ended on one of concern for the viability of the adult service. This has been due to the fact that NHS Highland had acknowledged the key role CC:SL has played in the past by their award of funding for three years. This was in response to the fact that 50% of our adult referrals were coming from GPs and related health services. With this funding we were able to respond within a reasonable timescale of a few weeks, rather than clients having to wait for many months, for any other mental health agencies to engage. In some cases, we were able to work with clients with serious long-term diagnoses to enable them to cope until the more focussed agencies were able to respond, At the end of this financial year, they didn't renew their commitment to funding and therefore threw in to doubt CC:SL's ability to respond, not only to these clients, but to the long term viability of the adult service.

In contrast the Children and Young people's service was awarded a continuation of our contract to respond to the client needs from the two ASGs Portree and Plockton. This is an acknowledgement of the long-term service that CC:SL has been supplying for more than 20 years to the schools in Skye and Lochalsh. There has been a gradual change of staff as the children's lead counsellor moved of their replacement stepped in and this process has continued with our search for a replacement as our long-standing Counsellor has intimated that she will be stopping counselling shortly. She is prepared to continue until one of our adult counsellors takes the training to become a children's counsellor, which should be completed shortly after the beginning of the next financial year.

After about 9 years as chair of Counselling Care it is time for me to also step down and allow newer members to step up. As is familiar to anybody involved in a voluntary organisation it is not only funding which provides an ongoing challenge but finding people who are able and prepared to donate their free time to helping run a voluntary organisation. This can be problematical. We have been extremely fortunate in being able to welcome how will be taking over as Chair in the coming months. She has considerable experience in the voluntary sector and takes over when there is a well-qualified, experienced and dynamic team of counsellors who will exercise the running of CC:SL to a high professional standard. I wish them all well in the future and will not be too far away to follow, with interest, the developments and be on hand to help and advice, if so required.

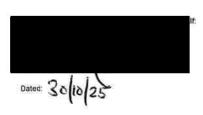

1) Accounting policies

Accounting Convention

Basis of financial statements

The financial statements have been prepared on a receipts and payments basis.

Unrestricted funds comprise grants and other income received for the objects of the charity without further specified purpose and are available as

general funds.

Designated funds represent unrestricted funds which have been earmarked by the Trustees for particular purposes,

Restricted funds comprise income which has been received for the objects of the charity and specified for a restricted purpose within these objects by the donor.
