#### **Community Involvement**

n July we had more than 30 members (Cubs, Scouts Explorers and Adults) spend 7 nights under canvas at our Summer Camp in Ettrick Valley.












After the summer holidays we participated in the District Training Camp and two weeks later all this year's practice paid off when our patrol took home the District Jubilee Camping Trophy!










In September our Beavers had a very popular visit from some Lamas, and a couple of weeks later a trip by train, to the National Museum of Scotland in Edinburgh.

# **Treasurer's Report**

#### **Reserves Policy**

The trustees believe that around 4 months of annual expenditure is an appropriate level of reserves to cover the timing differences between receipts and payments and to allow for any unexpected expenditure on repairs and maintenance of the Scout Hall and the Scout Equipment.

In addition a concerted effort has been made to fund-raise with the long term objective of replacing the roof of the Hall. Some of the funds have been gifted solely for that purpose, and additionally the trustees have allocated past savings, so that the total Restricted Funds allocated to Roof Replacement is £79,000.00

This Policy and the sum reserved will be reviewed on an annual basis.











## Independent Examiners Report to the Trustees

I report on the financial statements of the 5th Fife Scout Group ("the Group") for the year ended 31st March 2024 which are set out in pages herein.

#### Respective Responsibilities of the Trustees and Examiner

The Group's Trustees are responsible for the preparation of the accounts in accordance with the Charities and Trustee Investment (Scotland) Act 2005 ("the Act") and the Charities Accounts (Scotland) Regulations 2006 ("the Regulations"). The Group's Trustees consider that the audit requirement of Regulation 10(1)(d) does not apply. It is my responsibility to examine the accounts as required under section 44(1)(c) of the Act and to state whether particular matters have come to my attention.

#### Basis of Independent Examiner's Statement

My examination is carried out in accordance with the Regulations. An examination includes a review of the accounting records kept by the Group and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts and seeks explanations from the Trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

#### Notes to the Accounts

#### (1) Funds

a. The Group maintains an undesignated general fund for all its day to day financial transactions, the Trustees agree that this should not be less than four months' average expenditure to ensure there is sufficient available cash to pay for expenses as they arise.

The restricted fund, currently totalling £79,000.00 is being reserved for the replacement of the Scout hall roof, expected to cost around £85,000.00 and is expected to be completed in the next financial year. The Trustees allocate additional funds to this account at year end. In this year, the Trustees have allocated a further £10,500.00 to this fund, bringing the total restricted fund to £79,000.00.

- (2) Trustees Remuneration and Expenses
