Senior Staff member responsible for day-to-day management of the charity:

The charity has income below £250,000, and as such is eligible to prepare its accounts on a "Receipts and Payments" Basis. The governing document does not require the charity to prepare fully accrued accounts and neither does it require an audit. The accounts have been prepared in accordance with SORP 2015 issued by the Office of the Scottish Charity Regulator in its role as a SORP making body, recognised by the Financial Reporting Council. STRUCTURE, GOVERNANCE, MANAGEMENT

Governing document: The Trust is administered in accordance with the terms of the Trust Deed. The Charity is registered with the "Office of Scottish Charity Regulator".

Organisational structure and decision-making process: The Trustees are the managerial arm of the charity. They meet regularly and make decisions for and on behalf of the church. Major decisions of a managerial and financial nature are minuted.

How trustees are appointed and recruited: Appointment and removal is in accordance with the Trust Deed which requires that appointment is approved by unanimous agreement of the existing trustees and removal of any trustee by the unanimous agreement of the others.

Risk Management: It is considered by the Trustees that there is no foreseeable risk where the charity is exposed.

Affiliations and connections: The charity is affiliated with the "Assemblies of God, Great Britain". ("Assemblies of God" is a company limited by guarantee (No. 2873415) registered in England, having its registered office at "Gf/F12 No. 1-2 The Cottages, Deva Centre, Manchester, England, M3 7BE" and is also a registered charity (No. 1032245)).

OBJECTIVES AND ACTIVITIES

The Purpose of the charity as set out in the governing document: The purpose of the charity is the advancement of religion; provision of assistance to those in need through age, ill-health, disability, financial hardship or other disadvantage. The church building is located in the heart of the east end of Glasgow and is a central focal point for the local community.

Summary of the main activities in relation to those purposes:

- ✓ continual weekly meetings; Sunday morning, Tuesday evening.
- ✓ children's programme on Tuesday evening for children in the community from deprived homes.

Volunteers: The church would not be able to function without the help of volunteers in the areas of supervision of children, music, serving and cooking, teaching, maintenance & administration. The Trustees would like to thank all volunteers for their invaluable contribution to the life of the charity. The Trustees acknowledge that the public benefit would not be possible without these volunteers.

ACHIEVEMENTS AND PERFORMANCE

We began 2024 with a core leaders / emerging leaders day away in Cumbernauld with guest speaker

In February we again welcomed the Celtic Charitable Foundation & the Islamic Relief Foundation to the church for a joint food drive. 3 tons of non perishable food was brought from LIDL, deposited at Gateway and a team of volunteers packed all the non perishable goods into 300 bags. Within 24 hours the food was then distributed all over the city to schools and organisations.

Delighted to report that the Celtic Foundation have committed to giving 15K towards our community projects in 2024. 7:5K has already been given with the balance due to be given in the summer.

March was a big month for the church with a team of 7 people heading off on short term mission to Tondo, Philippines. It was a fantastic trip - wonderful to see the amazing work of KCM in one of the worst slum areas in Manila.

The team served in a variety of ways including kids work, training kids leaders, feeding programmes, pastors seminars, practical work & taking part in church services.

One week after returning a huge fire broke out in a building behind the church. Thankfully there were no casualties but 800 families lost their homes and possessions. Gateway immediately launched a "Fire Appeal" and just over £8300 has currently come in. Add to that the £2,000 gift to meet a specific need there - Gateway has given over 10K in the last month from our missions account to the work of KCM in Tondo, Manila.

Last September saw us going through John's Gospel as our primary teaching tool on Sunday mornings. We finished the series mid April and from the beginning of May we are about to start a 4 week series on "Created to dream - the different phases Gods uses to grow our faith".

We held our quarterly men's event in February with over 20 guys enjoying breakfast together and hearing some real life stories from guys at church.

Next men's night will be June 1st with the Champions League Final being shown on the big screen at church.

We are beginning the preparations of getting involved in the upcoming 'God Loves You Tour' event at the Hydro, Glasgow with Franklin Graham in June 2024. In preparation for that we will be hosting a CLWC night in early May to equip people to be counsellors and stewards at the event.

All the regular weekly activities are on at church with kids clubs, small groups, prayer nights, toddler group, dinner project and community cafe being some of the ongoing ministries. Also the Chinese Church is still meeting in the building on Sunday Afternoon.

We give God thanks for his goodness and grace upon the life of this developing east end church.



FINANCIAL REVIEW

Total receipts for the financial year 1st April 2023 to 31st March 2024 was £196,261 (£159,971 in 2023).

Total payments were £180,890 (£136,658 in 2023).

Net income was £15,370 (£23,314 prior year).

The Church would like to thank "Celtic Charitable Foundation" for their grants of £22,000 which enable the operation of the Community Café and all food related projects. The Transfer of £17,787 were community café expenses spent from the grant income as well as ministry expenses by the Community Pastor. The café has grown to the extent that in the subsequent financial year, the café expenses will be shown separately with its own expense account.

Designated donations were donations for hardship payments for community residents, and also a fire appeal in the Philippines.

Missions payments includes donations for the flights for the Philippine Mission trip. Overseas missions expenses included payments for these flights. Payments also includes donations to "Open Doors". Philippines Missionaries (Domingo) & Ministry. Syia missions was £1,000.

Repairs & Maintenance includes £6,830 for the car park.

Outreach & Hospitality includes food and requisites for the community café and Pastor's hospitality costs.

Besides reimbursements of expenses, all expenses were for the continuing operation of the church.

Going Concern: As at the date of approval of this report, and the financial accounts, the Trustees have assessed that there is no uncertainty about the Charity's ability to continue as a going concern.

FUTURE PLANS

Plans for future periods: More ministry is planned throughout the year.

The Trustees believe that this report is a fair, balanced and an understandable review of the charity's structure, legal purposes, objectives and activities, financial performance & financial position.

INDEPENDENT EXAMINER'S REPORT ON THE ACCOUNTS

REPORT TO THE TRUSTEES OF "GATEWAY CHURCH GLASGOW"

I report on the accounts of the charity for the year ended 31st March 2024 which are set out on pages 9 to 13.

Respective responsibilities of Trustees and Auditors

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) 2005 Act and the Charities Accounts (Scotland) Regulations 2006. The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of Independent Examiner's statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts and seeks explanations from the trustees concerning any such matters. 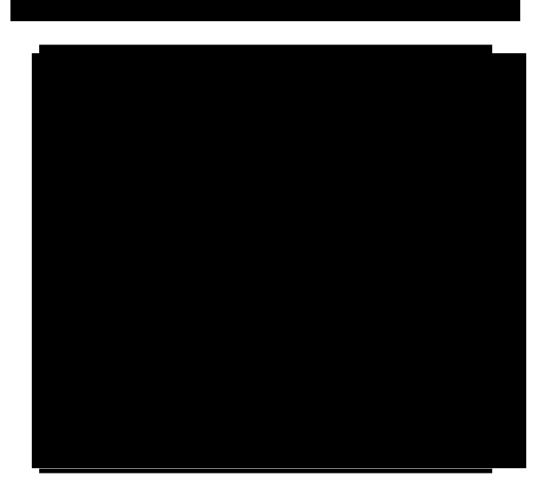
