REPORT OF THE INDEPENDENT EXAMINER TO THE MEMBERS OF GARNOCK VALLEY PIPES & DRUMS SC047914

I report on the accounts of the charity for the period from 1 December 2023 to 30 November 2024 which are set out on pages 1 & 2.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006. The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the 2006 Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiners' statement

My examination is carried out in accordance with Regulation 11 of the 2006 Accounts Regulations. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

Garnock Valley Pipes & Drums Treasurer's Report

Executive Summary

1. The past 12 months have seen a significant revival in the Band's finances. Due to constraints imposed on fundraising during the COVID-19 Pandemic, our ability to raise funds over the previous 3 years was severely constrained. As a result, the Band in the main survived on the residual capital left over from a substantial grant awarded by SSPDT on our formation in 2017. Over the last year the Committee, with invaluable assistance from Beith Community Development Trust, have succeeded in generating funds from a diverse range of sponsors and also through local fundraising activity (most notably a very successful Ceilidh at Geilsland on 16 Feb 24). Thanks to this, GVP&D can look forward to a relatively stable financial outlook for the next 11-12 months, although further fundraising will be required over the next 3-6 months to ensure that this remains sustainable going forward.

Band Funds




Fig 1: GVP&D Funds Nov 21 - Jun 24

2. Fig 1 (below) shows the variation in available funds over the last 3 years:

The headline balance (at the time of writing) is £18077.26. This is a significant improvement in finances compared with the previous 3 years' accounts.

Income and Expenditure Analysis

3. Table 1 (below) provides a breakdown of income vs expenditure for the last 3 years:

(*: £3092.00 in FY24 expenditure has been carried over from FY23 as payments were delayed due to an enforced bank account change in Q3-4/24. Accordingly, the FY23 deficit is artificially low, as is the FY24 credit by a corresponding amount).

The post-pandemic easing of restrictions on fundraising has allowed the committee to arrest the steady deterioration in the band's finances over the preceding 3 years. As far as possible, the intention going forward will be to operate on a 'break even' basis.

Look Ahead

- 4. A professional audit of the FY23 accounts is underway, and will be completed in time to meet the deadline to file the annual return to SCIO (31 Aug 24).
- 5. Although the headline balance is much improved, the following caveats apply:
 - a. A reserve (minimum allowable balance) of £3000 has been established. This represents an estimated 3 months' routine running costs. Were this reserve to be reached, it would allow sufficient notice for an Emergency General Meeting to be convened to take any necessary remedial action before funds run out entirely.
 - b. A sum of £4000 is reserved to pay for the services of a part-time Project Coordinator, who is employed through Beith Community Development Trust to provide professional support to the GVP&D Committee. The funding for this post (which has proven vital in supporting fundraising and outreach activity over the previous 12 months) was sourced from the National Lottery Community Fund for that purpose and cannot be used in any other way.

- 6. With the considerations in para 4 (above) in mind, remaining funds will allow GVP&D to keep conducting its current activities until May/Jun 25. This is contingent upon ensuring that routine operating costs do not exceed £1000 pcm.
- 7. If current activity is to be sustained beyond that time, a new round of fundraising will need to commence in Q3/24, ideally straight after the School Summer Break. As band numbers expand, it is also likely that the current equipment inventory will need to be enhanced. As current operating costs are almost entirely consumed by tuition fees, the increase in costs required to cover this adds even more importance to the need to source additional financial support going forward.

Conclusion

8. After a busy and at times turbulent transitional year, the improvement in GVP&D's finances has afforded a degree of stability in the short to medium term. However, further fundraising effort will be required in the near future if this stability is to be sustained, especially as we seek to widen engagement with the Garnock Valley community.

Explanatory Notes:

- 1. The start of this accounting period coincided with the migration to a new (SCIO-compliant) bank account (Garnock Valley Pipes and Drums SCIO, Sort Code 83-23-19, a/c No 00610343). The band's remaining funds (£7983.79) were transferred on 2 Dec 23, as reflected in the opening statement.
- 2. In May 24, the band changed its registered address

o reflect the

administrative reality of our re-basing at the Beith Community Development Trust facility in Geilsland. Unfortunately, the May 24 and Jun 24 bank statements went astray during this process. However, RBS provided a summary of all transactions conducted over that period, which is included with the bank statements.

3. Six cheques (nos 000027-000032 inclusive, for £40.00 each) were written to cover 'thank-you' gratuities to 6 young volunteer tutors who helped run the Summer School in Aug 24. Given the nature of the payments there are no accompanying invoices, however this expenditure was unanimously approved by the Band Committee and is recorded in the Record of Decisions.
