STRUCTURE GOVERNANCE AND MANAGEMENT

Governing Document

Cymera Festival is a Scottish Charitable Incorporated Organisation (SCIO) and received charitable status on the 5th November 2018 with the charity number SC048809. The charity is governed by its Constitution.

Appointment of Trustees

The Charity Trustees who are the members of the charity, are also known as the Board of Trustees.

The Charity Trustees are recruited by the members of the organisation at the Annual General Meeting (AGM) and any other vacancies can be filled by appointment.

Under the Constitution, there must be a minimum of 3 trustees and a maximum of 11. At each AGM, all the Charity Trustees must retire from office, but may be re-elected. There is no limitation on the number of terms served.

Employees of the organisation cannot be nominated as or become Charity Trustees.

Organisational Structure

The organisation is comprised of Members and Charity Trustees.

Membership is open to organisations and any individuals aged 16 or over who demonstrate an affiliation with the organisation's purpose. The Members appoint people to serve as Charity Trustees and take the decisions on changes to the Constitution.

The Charity Trustees are responsible for the activities of the organisation and the monitoring and controlling of its financial position.

OBJECTS & ACTIVITIES

Charitable Purposes:

Cymera Festival was established with the following charitable purposes:

• The advancement of the arts, heritage, culture, or science.

Activities:

Cymera Festival is an annual celebration of science fiction, fantasy and horror writing that aims to nurture the enjoyment of those genres by bringing together writers and readers from Scotland and beyond to share ideas, create stories and celebrate their imagination.

ACHIEVEMENTS & PERFORMANCE

The team were excited to welcome readers and writers back to The Pleasance, Edinburgh from Friday 2nd to Sunday 4th June 2023. The festival felt like the first "normal" festival after the pandemic, with more people attending and restrictions fully lifted.

Nevertheless, Cymera remains committed to hosting a hybrid festival, to keep the festival accessible for participants and attendees. In addition to a purely digital strand primarily featuring international authors, all inperson panel events were livestreamed to YouTube, once again in collaboration with Edinburgh-based livestreaming company Channel 7A. We also hosted our first two truly hybrid events, with two authors Zooming into an in-person event at Pleasance, one due to illness, the other due to a train cancellation.

Over three days, Cymera23 hosted over 70 events, including 32 panels, 13 workshops, two open mics, the quiz and a number of RPG and Board Game sessions, hosted in collaboration with Edinburgh-based board game shop Ancient Robot Games. The programme featured over 120 participants, and 25 percent of speakers joined us from outside the UK. Highlights included (Australia), (US), (US), (US), (US), (US), (US), (France) and (Philippines). The festival aims to providing a diverse and interesting programme. For 2023 we were delighted to host Edinburgh-based theatre company Strawmoddie with their production of Terry Pratchett's Guards! Guards!, selling out all three performances. For sci-fi fans, Dune The Musical! had its world-premiere at Cymera, and returned to Cymera with his solo show Devil in the Belfry.

In total (but excluding the Pratchett play), 1324 tickets were sold for events at the 2023 festival. While still not back up to pre-covid levels (2019: 1824 tickets), this is an improvement on 2022 and an encouraging growth.

Weekend passes remain popular, with 92 in-person (of which 66 early-bird) and 25 digital-only (of which 23 early-bird) passes purchased for the festival. The festival also remains committed to providing complimentary weekend passes to those who are unable to join the festival otherwise, and a total of 30 passes were requested, 13 digital-only and 17 for in-person.

Following the success in 2021 and 2022, all live events had a dedicated moderator, who was monitoring the livestream or Zoom Webinar chat and encouraging attendees to get involved. Our in-person chairs' effort to include the audience watching on the livestream worked well and were much appreciated.

The Agent One to One feedback sessions returned, and additional sessions were added due to the demand. The in-person sessions were supplemented by a digital one, and all slots were snapped up.

The free Inside Science Fiction, Fantasy and Horror Publishing sessions moved into their own space. The events were supported by the Society of Young Publishers Scotland, and SYP chair Averie Watson took on the role of interviewer for them.

The Creator's Hall was filled to the brim with exhibitors, making it our busiest year yet. Due to a clash with Glasgow Comic-Con on Saturday, Sunday was the busier day for exhibitors, as many comic exhibitors only joined us for that day.

Creating an inclusive and relaxed atmosphere is a big part of what we do. Admittedly the great weather really made a big difference to the festival, as people were able to sit in the courtyard and just enjoy hanging out. Nevertheless, the post-event survey highlighted that we were once again successful in making the festival a great place to be.

Cymera beyond the festival

For the first time, Cymera hosted a Writers' Conference in November 2023. The one-day event was dedicated to the craft of writing Science Fiction, Fantasy and Horror and provided networking opportunities with fellow writers and agents and editors from the Scottish literary landscape. The in-person event was held at Nicolson Square, with the in-person events livestreamed and a digital-only programme on Zoom.

The conference was supported by funding from Book Week Scotland and part of the BWS programme. Just over 70 writers attended, the majority in-person and just six people attending online only.

However, 2023 was a difficult year financially. After the application to Creative Scotland was unsuccessful, the festival had to make significant savings while also using up any reserves. A successful application to the People's Postcode Trust secured funding for the livestreaming, and additional funds were raised through publisher sponsorship and private donations. This situation reinforced the importance of a balanced funding portfolio, and its development is one of the festivals' strategic priorities for the next three years.

The year also brought changes in the board, following resignation, the remaining trustees set out to recruit new trustees to the board, especially reaching out to individuals with a background in fundraising, EDI and marketing. Four new trustees joined the board at the 2023 AGM in January 2024, bringing some much-needed expertise and fresh ideas to the festival.

FINANCIAL REVIEW

Overview

Income of £45,403 (2022: £33,929) was received and the main source of funds were from grants and ticket sales.

Expenditure totalling £51,241 (2022: £40,581) were made carrying out the charitable activities.

At the end of the financial period, the charity had a deficit of £5,838.

Donated Facilities & Services

The Charity Trustees would like to thank the service provided by all the charity's volunteers, who have helped contribute towards the success and achievements made within this past year.

Reserves Policy

Reserves at the end of the year were £1,128. The Charity Trustees have set a policy of £3,000 to cover website costs and the engagement of a freelance administrator. They have not met their target and the financial position will be monitored carefully throughout the year by the Charity Trustees.

Since its first festival in 2019, Cymera has successfully established itself as the premier destination for SFFH readers and writers in the UK, with audience numbers growing year-on-year. The festival aims to grow its digital audience and attract more attendees from beyond Scotland, while also increasing its involvement in the writing community in Scotland.

Independent Examiner's Report to the Trustees of Cymera Festival

I report on the accounts of the charity for the year ended 30 November 2023, which are set out on pages 9 to 13.

Respective responsibilities of Trustees and Examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 ("the 2005 Act") and the Charities Accounts (Scotland) Regulations 2006 (as amended) ("the 2006 Regulations"). The trustees consider that the audit requirement of Regulation (10)(1)(d) of the 2006 Regulations does not apply. It is my responsibility to examine the accounts under section (44)(1)(c) of the 2005 Act and to state whether particular matters have come to my attention.

Basis of Independent Examiner's Statement

My examination is carried out in accordance with Regulation 11 of the 2006 Regulations. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.
