#### STRUCTURE GOVERNANCE AND MANAGEMENT

#### **Governing Document**

Cymera Festival is a Scottish Charitable Incorporated Organisation (SCIO) and received charitable status on the 5<sup>th</sup> November 2018 with the charity number SC048809. The charity is governed by its Constitution.

#### **Appointment of Trustees**

The Charity Trustees who are the members of the charity, are also known as the Board of Trustees.

The Charity Trustees are recruited by the members of the organisation at the Annual General Meeting (AGM) and any other vacancies can be filled by appointment.

Under the Constitution, there must be a minimum of 3 trustees and a maximum of 11. At each AGM, all the Charity Trustees must retire from office, but may be re-elected. There is no limitation on the number of terms served.

Employees of the organisation cannot be nominated as or become Charity Trustees.

#### **Organisational Structure**

The organisation is comprised of Members and Charity Trustees.

Membership is open to organisations and any individuals aged 16 or over who demonstrate an affiliation with the organisation's purpose. The Members appoint people to serve as Charity Trustees and take the decisions on changes to the Constitution.

The Charity Trustees are responsible for the activities of the organisation and the monitoring and controlling of its financial position.

### **OBJECTS & ACTIVITIES**

### **Charitable Purposes:**

Cymera Festival was established with the following charitable purposes:

• The advancement of the arts, heritage, culture, or science.

#### **Activities:**

Cymera Festival is an annual celebration of science fiction, fantasy and horror writing that aims to nurture the enjoyment of those genres by bringing together writers and readers from Scotland and beyond to share ideas, create stories and celebrate their imagination.

2024 Attendee feedback

2024 was a busy year for the Cymera team. Four new trustees joined the board in January 2024, bringing new ideas and energy to the 2024 festival and the Writers Conference in November 2024.

Preparations for the sixth festival were thrown into disarray when global pop superstar Taylor Swift announced three concerts at Edinburgh's Murrayfield Stadium over the festival dates. Faced with high hotel prices and a

lack of accommodation options, the Board decided to move the festival forward by a week, running 31st May to 2nd June 2024.

Nevertheless, our 2024 Festival was a great success, with attendee numbers once again growing. Over three days, Cymera hosted over 70 events, including 32 panels, 16 workshops, two open mics, the quiz and a number of RPG and Board Game sessions, hosted in collaboration with Edinburgh-based board game shop Ancient Robot Games

.

The weather was almost too kind to us, which resulted in some of the venue spaces becoming very hot, but attendees very much enjoyed spending time in the courtyard.

The programme featured over 130 participants, and 16 percent of speakers joined us from outside the UK.

Our digital offering remains popular, and the headline digital event with bestselling US author Cassandra Clare (interviewed by Edinburgh-based author V.E. Schwab) resulted in ticket bookings from across the world, including Australia, Canada, Israel, Luxembourg, Serbia and Poland. Multiple bookings from Germany, Ireland, the Netherlands and France indicate that Cymera's reputation is growing in Europe.

Scottish writers were once again well-represented in the programme, and it was a strongest female line-up yet, with almost 75 percent of all participants identifying as female.

The festival continues to provide a diverse and interesting programme. For 2024 we were delighted to welcome back Edinburgh-based theatre company Strawmoddie with their production of Terry Pratchett's Men at Arms, adding a fourth performance on Thursday night due to popularity! For sci-fi fans, Dune The Musical! returned to Cymera for a second year, and performed his work-in-progress piece A Rose Appears.

"[My favourite thing about Cymera 2024 was] the people and the atmosphere - it was so lovely to chat to random strangers and become friends simply because we were at a great event together. I also really liked the obvious immense amount of work that had gone into making sure there were so many great events for everyone, and so much Scottish/local talent.".

2024 audience feedback

In total (but excluding the Pratchett play), 1388 tickets were sold for events at the 2024 festival. Weekend passes remain popular, with 103 in-person (of which 62 early-bird) and 20 digital-only (of which 14 early-bird) passes purchased for the festival. The festival also remains committed to providing complimentary weekend passes to those who are unable to join the festival otherwise, and a total of 36 passes were requested, 19 digital-only and 17 for in-person. Cymera also collaborated with the Scottish BPOC Writers network to provide Scottish writers of colour with weekend passes.

The ability to engage a Volunteer Coordinator was invaluable. Not only did this free up the rest of the team, it improved the volunteer experience immeasurably. With over 60 volunteers, this has been out most successful volunteer year yet, and it was brilliant to see so many familiar faces returning for another year.

#### Cymera beyond the festival

On 9th November 2024, Cymera took over Central Hall, Tollcross, Edinburgh for our second Writers Conference, with a jam-packed programme for writers, with panels, talks, workshops, Agent one to ones and networking opportunities.

While the event remains small, we saw a ten percent growth in ticket sales, and more attendees showed their trust in us by buying Early-Bird tickets before we announced the conference speakers. Also encouraging is the growth in digital attendees, and Cymera remains committed to hosting the conference as a hybrid event.

Community building took centre stage at the conference with a dedicated panel on How to Build a Writing Network, while the conference with a workshop on Mental Health Care for Writers. Feedback from the event shows that attendees really enjoyed the selection of panels.

In addition to the two key events, the Cymera team also attended WorldCon in Glasgow. Cymera shared a table in the Dealers Hall with Edinburgh-based sci-fi magazine Shoreline of Infinity, handing out leaflets and speaking with attendees. Several members of the team also took part in events and panels. Festival director Ann was on several panels, including hosting the Special Guest interview with

2024 was a year of rebuilding and consolidation for the Cymera team. The lack of Creative Scotland funding the previous year meant that securing the funding for 2024 was key, as reserves were depleted and costs such as venue hire and accommodation were increasing. Following the 2024 festival, the board set up a Development Working Group to work a towards a more robust funding model. This was just one of the ideas and approaches the new trustees brought to the festival, together with professionalizing Cymera's Social Media, adding expertise to panels and supporting the running of the Writers Conference.

### **FINANCIAL REVIEW**

#### Overview

Income of £61,230 (2023: £45,403) was received and the main source of funds were from grants and ticket sales.

Expenditure totalling £60,981 (2023: £51,241) were made carrying out the charitable activities.

At the end of the financial period, the charity had a surplus of £249.

#### **Donated Facilities & Services**

The Charity Trustees would like to thank the service provided by all the charity's volunteers, who have helped contribute towards the success and achievements made within this past year.

#### Reserves Policy

Reserves at the end of the year were £1,613. The Charity Trustees have set a policy of £3,000 to cover website costs and the engagement of a freelance administrator. They have not met their target, and the financial position will be monitored carefully throughout the year by the Charity Trustees.

### Independent Examiner's Report to the Trustees of Cymera Festival

I report on the accounts of the charity for the year ended 30 November 2024, which are set out on pages 9 to 12.

#### Respective responsibilities of Trustees and Examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 ("the 2005 Act") and the Charities Accounts (Scotland) Regulations 2006 (as amended) ("the 2006 Regulations"). #### **Basis of Independent Examiner's Statement**

It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.


#### **Independent Examiner's Statement**

#### 1. Basis of Preparation

These accounts have been prepared on the receipts & payments basis in accordance with:

- (a) The Charities and Trustee Investment (Scotland) Act 2005
- (b) The Charities Accounts (Scotland) Regulations 2006 (as amended)
