1. STONEHOUSE MEN'S SHED

1.1 INTRODUCTION

This report and set of financial accounts is being compiled by the Trustees of Stonehouse Men's Shed (SC049237) to meet the requirements of the Office of the Scottish Charity Regulator for the period 1st November 2023 to 31st October 2024.

1.2 BACKGROUND

'Sheds' are a response to men's needs for camaraderie and provide opportunities to tackle loneliness and isolation by socialising and working together in a way that contributes meaning to their lives and communities.

Stonehouse Men's Shed was formed as a club in May 2018, meeting in Stonehouse Lifestyles. Despite being restricted in its activities due to the limitations of its location, its membership, meeting weekly, grew to over 30 at the time of its registration as a charity in April 2019, at which time a constitution approved by the Charities Regulator was adopted by unanimous agreement of the membership.

1.3 TRUSTEES and COMMITTEES

A single management committee, comprising the five trustees elected at the AGM on 23rd February 2022, plus two co-opted since, runs the Shed, and is as follows:-



1.4 MAIN ACTIVITIES DURING THE YEAR 2023-2024

Regular meetings continued in the recently-completed clubhouse. Membership increased slightly and attendance is around 20, not helped concerns and after effects of the virus on a predominantly older membership. Activities centre on a Monday afternoon social gathering, although the music group is particularly active and the woodwork shed has been kitted out and is in regular use. An external rewilding project has now been completed on adjacent derelict ground, and is proving very popular.

1.5 **MEMBERSHIP**

Membership is open to all adults over 18 in the South Lanarkshire area. There are currently 46 registered members of the Shed, predominantly from Stonehouse and surrounding villages.

2. REPORTS

(As presented to members at the AGM)

2.1 CHAIRMAN'S REPORT

At its AGM, the Chairman thanked his committee of trustees for their tireless work in running the Shed – the Secretary, the Treasurer, the Back Yard Manager, the Policies Manager, the Beekeeper, and non-executive duties.

During the year, the Shed held regular Monday chat meetings, celebrated birthdays, made bird boxes, hosted community meetings, maintained bee hives and collected honey, visited three other Men's Sheds, visited Summerlee Museum, repainted the two portacabins, ran Spanish lessons, and opened its doors to the public on two occasions.

'Rob's Back Yard', our garden re-wilding project, reached completion after 18 months hard work, and was opened in May by efore his untimely loss. It has become a real but hidden oasis in the local village, hosting barbeques, educational visits from the local primary school, and becoming a summer sitting area for members.

Sadly during the year, the Shed lost Leader of the rewilding team and community stalwart, and its oldest member.

'Simply Shed', the members' guitar band playing predominantly '60s music, was in much demand, visiting many local retirement homes, guilds, and pensioner clubs.

The Shed's membership increased slightly while active attendance remained in the twenties each week. An unsuccessful attempt was made to hold regular evening meetings in the summer, but this will be renewed next season.

Next year the Shed looks forward to much more of the same, including visits, the restoration of a Bantam motorbike, a Race Night fundraiser, and hosting local business enterprises during a two-day Arts Trail.



3. FINANCIAL ACCOUNTS

3.1 TREASURER'S REPORT

A signed copy of the Annual Accounts for the period 1st November 2023 to 31st October 2024 was presented at the AGM and also follows on the next page.

It will show a substantial amount of fundraising, donations, and grants which has allowed the Shed to substantially complete the rewilding project. This has also enabled the Shed to maintain a good working fund for running expenses, etc, to see us through the next year. The charity has no debts.

3.2 NOTES ON THE ACCOUNTS

- The accounts have been prepared on an Income and Expenditure basis in accordance with the Charities and Trustees Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 as amended.
- 3.2.2 "Subscriptions" took the form of a small weekly donation to cover tea, coffee and biscuits (covered under "Sundries & Expenses")..
- 3.2.3 Expenditure, sundries and expenses were also incurred for stationery, postage, printing, etc, required for the normal running of a club.
- 3.2.4 Grants received under Restricted Funds were heavily expended, but there remains a balance of £5,746 in that account.
