Objectives and activities

Charitable purposes

The objectives of the Trust are to protect, restore and maintain aquatic biodiversity, particularly native fish, in the burns, lochs and associated coastal areas of Orkney. It will do this by:

- (a) encouraging practical, responsible and sustainable approaches to land and water management, which embrace sound science and evidence-based decision making for the benefit of the wider community;
- (b) provide advice and support to practical works that restore, protect and maintain aquatic habitats, with a particular emphasis on increasing resilience to climate change;
- (c) managing projects to improve habitats and water quality of lochs and burns in Orkney; and
- (d) running education programmes for schools, colleges, communities and volunteers.

Achievements and performance

Summary of the main achievements of the charity during the financial period

Activities in this first year started with the establishment of the OWT structure, Trustee membership and development of appropriate policy and procedures, which is ongoing. Other basic work included setting up Microsoft and email accounts.

Work towards the Trust objectives began with engagement with relevant local & national stakeholders to introduce the Trust and its objectives, identify common interests and future opportunities for collaboration. This led to one successful funding application to enable the purchase of essential electrofishing equipment and the development of a project proposal as part of the North Isles Landscape Partnership (NILPS) Project.

The Trust secured membership of Fisheries Management Scotland, and was subsequently involved in planning delivery of a Scotland-wide sea lice monitoring project.

We also secured commercial work relevant to our objectives, that included providing advice to a contractors undertaking stream crossings as part of the Orkney Link Cable Project.

Financial review

We are yet to finalise a formal reserves policy but aim to within the next 6 months. We will have a better idea of core operation costs by then to inform a policy. Looking to financial year of 2025/26 we anticipate core costs associated with insurance and IT services and have built them into funding applications as part of overheads.




