The Trustees present their annual report and financial statements for the Trust for the year ended 31st October 2025. The financial statements have been prepared in accordance with the accounting policies set out in Note 1 to the financial statements and comply with the Charity's Trust Deed, the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 (as amended) and the Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their financial statements in accordance with the Financial Reporting Standard 102 applicable in the UK and Republic of Ireland (FRS 102) (second edition issued October 2019 and effective 1 January 2019).

Objectives and Activities

Objectives of Trust

The Trustees are directed in terms of the Trust Deed to pay or apply the income or capital of the Trust Fund for the benefit of or in furtherance of the following purposes, objects or institutions, charitable in law, and in such proportions as the Trustees shall think fit:

- 1) The advancement of the arts and culture in particular by the care and management of the paintings, works on paper and archives of the late Jon Schueler;

- 2) The advancement of education by giving financial support and encouragement to education and training in the visual arts, in particular painting, through grants or loans to other charities with similar charitable purposes or to individuals; provided that in the case of individuals such grants are awarded on an objective and non-discriminatory basis pursuant to a procedure approved in advance by the United States Internal Revenue Service.

The Trustees may not accumulate any of the income of the Trust Fund.

In furtherance of the objectives the Trustees aim to advance the public knowledge of Jon Schueler and his contemporaries in a contextual way through the support of exhibitions and publications and by making grants, facilitating the placement of works in museums and galleries and gifts to other charitable organisations.

Grant Making Policy

The Trustees have opted for a policy of making donations to those organisations and individuals they feel require most support and whose purposes fall within the spectrum of the Trust Deed.

Achievements and Performance

Investment Policy
and Performance

In accordance with the Trust Deed, the Trustees have power to invest in such stocks, shares, investments and property in the United Kingdom or abroad as they in their sole discretion think fit. The Trustees engaged RBC Brewin Dolphin as investment managers.

The Trustees' investment policy is geared towards a balanced return between capital and income. There are no constraints as to the investments comprising the portfolio at any time.

Investment Policy
and Performance

As at 31st October 2025, the value of the investment portfolio was £4,728,439.44 (2024 £4,194,251.22), an increase of 12.74% in the year.

Dividend income increased by 181.49% reflecting a full year's income against the part year income received in 2024.

Report on Activities

Donations totalling £1,000.00 were made in the year (2024 £1,030,500.00) as recorded at Note 5.

Future Plans

The Trustees at present have no commitments in place. The Trustees continue to review their grant giving policy and public access to the Artworks held by them.

Financial Review

Financial Report

The Trust Funds comprise Artworks, Investments and cash balances. At the close of the financial statement, the investments were valued at £4,728,439.44 (2024 £4,194,251.22) and the Artworks were included at their carrying value of £8,168,609.37.

There are net current assets of £165,367.74 (2024 £130,910.19).

During the period the Trust received income of £82,510.94 (2024 £13,307,905.27) including a donation of cash totalling £12,514.16 (2024 £13,821.25), investments of £NIL (2024 £5,084,881.52) and Artworks of £NIL (2024 £8,166,574.57) from the Settlor of the Trust.

Donations awarded in the year amounted to £1,000.00 (2024 £1,030,500.00).

Reserves Policy

It is the policy of the Trustees to distribute the income of the Trust in the form of grants or donations. It is anticipated that, where possible, any surplus income at the close of the financial statements would be so distributed in a following year.

The Trust Funds amount to £13,062,416.55 (2024 £12,491,735.98) which is wholly unrestricted. Trust Funds may be drawn on in furtherance of the Trust's objectives whilst retaining sufficient funds to meet any commitments they may undertake.

As the Trust does not provide direct charitable services, the Trustees believe that normal expenditure can be met from the existing funds.

As the assets of the Trust are held in a ready realisable form the Trustees do not, therefore, consider it necessary to maintain specific reserves.

Risk Management

The Trustees have assessed the major risks to which the Trust is exposed, in particular those related to the operations and finances of the Trust and are satisfied that systems are in place to mitigate exposure to the major risks.

Artwork Risk:

The Trust mitigates risks associated with artwork valuation through periodic review of values and, where appropriate, professional appraisal. Risks relating to loss, theft or damage are managed through appropriate insurance, security measures, environmental controls and established procedures governing the storage, handling and display of artwork.

Investment Risk:

As the Trust relies on its investment returns in order to operate, the principal risk faced by the Trust lies in the performance of its investments. The Trustees have mitigated this by retaining investment managers to advise them and by having a diversified portfolio.

Financial Review

Going Concern

The Trustees have no material uncertainties as to the Trust's ability to continue as a going concern.

Structure, Governance & Management

Founding Document

Deed of Trust dated 7th March 2007 and registered in the Books of Council and Session on 31st May 2007.

Appointment of New Trustees

There shall be a minimum of three and a maximum of seven trustees in office at any one time, with the majority of trustees being permanently resident in the United Kingdom.

The normal term of office shall be six years and appointments may be renewed.

The Trustees shall appoint from their own number a Chairman who shall hold office for a period of one year with power to be reappointed for succeeding periods of one year.

In the event of a tie in votes the Chairman shall have a casting vote in addition to his or her own vote.

Trustee Training

No formal training has been received by the Trustees.

Turcan Connell has been appointed as legal agents to the Trust and regularly appraises the Trustees of their duties and responsibilities.

Decision Making

All Trustees are actively involved in the decision making process. Requests for funding are reviewed by the Trustees.

Employees

The Trust has no employees (2024 None). The Trustees have engaged Turcan Connell to undertake the administration of the Trust remuneration, for which is recorded in the financial statements.

Management

All Trustees are active in the management of the Trust and are regarded as key management personnel.

Related Party Transactions

The Trustee Diana Ewer has received sums totalling £8,745.00 (2024 £5,565.00) from the Trust as a stipend for her duties as a curator.

During the year, the Settlor of the Trust gifted cash to the value of £12,514.16 to the Trust. In addition, the Trust received a donation of £3,652.20 from the Jon Schueler Foundation, a US based charity, of which Magda Salvesen is the Director. In 2024 the Jon Schueler Foundation received a donation of £1,000,000 from the Trust.

Opinion

We have audited the financial statements of The Jon Schueler Charitable Trust for the year to 31st October 2025 which comprises the Statement of Financial Activities, the Balance Sheet, the Statement of Cash Flows and notes to the financial statements, including a summary of significant accounting policies. The financial reporting framework that has been applied in their preparation is the applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice), including Financial Reporting Standard 102, The Financial Reporting Standard applicable in the UK and Republic of Ireland.

In our opinion the financial statements:

In preparing the financial statements, the Trustees are responsible for assessing the Trust's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the Trustees either intend to liquidate the Trust or to cease operations, or have no realistic alternative but to do so.

Auditor's responsibilities for the audit of the financial statements

We have been appointed as auditor under section 44(1)(c) of the Charities and Trustee Investment (Scotland) Act 2005 and report in accordance with the Act and relevant regulations made or having effect thereunder.

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with ISAs (UK) will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

Irregularities, including fraud, are instances of non-compliance with laws and regulations. We design procedures in line with our responsibilities, outlined above, to detect material misstatements in respect of irregularities, including fraud. The extent to which our procedures are capable of detecting irregularities, including fraud is detailed below:

- Irregularities that result from fraud are inherently more difficult to detect than irregularities that result from error.

We carried out income testing and expenditure testing, including grants payable, which was designed to identify any irregularities as a result of simple mistakes or human error. From this audit testing it was determined that the risk of material misstatement in this regard was low.

1 Accounting Policies

a) Financial statements preparation

The financial statements have been prepared under the historical cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant note(s) to these accounts. The financial statements have been prepared in accordance with the : Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their financial statements in accordance with the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102) (second edition issued October 2019 and effective 1 January 2019) and the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102) the Charities and Trustee Investment (Scotland) Act 2005, and the Charities Accounts (Scotland) Regulations 2006 (as amended).

The Trust constitutes a public benefit entity as defined by FRS102.

The financial statements have been prepared in pounds sterling as this is the functional and presentational currency of the Trust.

The financial statements have been prepared on a going concern basis. The Trustees have assessed the Trust's ability to continue as a going concern and have reasonable expectation that the Trust has adequate resources to continue in operational existence for the foreseeable future after taking into account funds received after the year end and the timing of payment of future grant commitments. Thus they continue to adopt the going concern basis of accounting in preparing the financial statements.

b) Artworks

The Trust's collection of Artwork is reported in the balance sheet at their carrying value. The Artworks are deemed to have an indefinite life therefore the Trustees do not consider it appropriate to charge depreciation.

c) Investments

Investments are a form of basic financial instrument and are initially recognised at their transaction value and subsequently measured at their fair value at the balance sheet date. The Statement of Financial Activities includes the net gains or losses arising on revaluation and disposals throughout the year.

Fair value revaluation of the portfolio at the account date is done at either mid market price or bid price depending on the nature of the investment.

d) Investment gains and losses

All gains or losses are taken to the statement of financial activities as they arise. Realised gains and losses are calculated as the difference between the sales proceeds and their opening carrying value or their purchase value if acquired subsequent to the first day of the financial year. Unrealised gains and losses are calculated as the difference between the fair value at the year end and their carrying value. Realised and unrealised gains and losses are combined in the statement of financial activities.

e) Income

Investment income is included in the financial statements in the year in which the Trust becomes entitled to it, it can be reliably determined and there is a probability of receipt.

Donations are included in the financial statements together with associated gift aid, where applicable, when the Trustees have been advised of the donation with notification of both amount and intended settlement date.

f) Expenditure

Expenditure is included in the financial statement on an accruals basis and recognised in full as soon as a constructive obligation exists, the sums payable can be reliably measured and there is probability of payment.

g) Valuation of assets

Investments are included at fair value at the year end. Other fixed assets are quoted at a value as determined by the Trustees, or where appropriate, relevant professional valuation.

h) Support and governance costs

Support costs are the costs associated with the direct management of the Trust.

Governance costs are the costs of compliance with the statutory and regulatory requirements of the Trust.

Fees charged by Turcan Connell for legal and accounting services are included in the accounts as follows:

Support (legal and administrative costs) - 70%

Governance (accountancy costs) - 30%

These are recorded in support and governance costs in the Statement of Financial Activities

Audit/Independent examination fees are recorded as support and governance costs in the Statement of Financial Activities.

All other support and governance costs are recorded in the Statement of Financial Activities as appropriate.

Support and governance costs are not allocated against individual grants or donations.

i) Grants

Grants payable are payments to third parties in furtherance of the charitable objects of the Trust. In the case of an unconditional grant offer this is accrued once the recipient has been notified of the grant award. The notification gives the recipient a reasonable expectation that they will receive the one-year or multi-year grant. Grants awards that are subject to the recipient fulfilling performance conditions are only accrued when the recipient has been notified of the grant and any remaining unfulfilled condition attaching to that grant is outside of the control of the Trust.

Grants authorised to be paid in respect of the accounting year or future years are provided for in the financial statements.

Provisions for grants are made when the intention to make a grant has been communicated to the recipient.

A provision for a multi-year award is recognised at its present value where settlement is due over more than one year from the date of the award, there are no unfulfilled conditions and the effect of the discounting is material. In the current economic climate the Trustees consider a discount rate of 2% to be appropriate.

j) VAT

The Trust is not registered for VAT purposes and all VAT incurred is therefore irrecoverable. Where applied, VAT is included as part of the expense.
