### **Report of the Trustees for the year ended 31 July 2024**

The trustees have pleasure in presenting their report together with the financial statements for the period starting 1 August 2023 and ending 31 July 2024.

The financial statements have been prepared in accordance with the accounting policies set out on pages 12 and 13 to the financial statements and comply with the charity's constitution, the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 (as amended), the Companies Act and "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102)" (as amended for accounting periods commencing from 1 January 2019).

## **OUR PURPOSES AND ACTIVITIES**

### **Charitable purposes**

To provide facilities for and promote the amateur sport of rowing ('rowing') in Edinburgh and the surrounding area and to provide facilities for and promote community participation in rowing.

### **Achievements and performance**

The 2023/24 season was a very successful one; both on and off the water. Our Junior and Senior Learn to Row graduates have been providing fresh members throughout the year and our continued performances at top end competitions have solidified the general opinion that St Andrew Boat Club is an excellent place to row.

The boat house, particularly its training space, continues to demonstrate how valuable an asset it is to the Club with group sessions providing a friendly and welcoming atmosphere no matter the level of rowing ability or ambition you have. The levels of commitment to training continue to be impressive and again demonstrated in the performances of all athletes. Along with the canal, Strathclyde Park and the utilisation of the facilities at Tay Rowing Club, we were able to offer and tailor our training to meet our wide range of goals for the season. This will continue next season with the good grace of our friends up on the Tay.

We continue to honour our 'Rowing for All' motto and are still pursuing how we can keep the sport inclusive for all. Work recently within the adaptive rowing category has further enhanced our ability to offer the sport to a wider body of the community. Our Junior section is formulating plans on how best to reach out to local schools such as James Gillespie's, Firhill and Boroughmuir to provide opportunities to their pupils, potentially through their active schools' section and indoor schools championships. This all gives us a fantastic and diverse membership which we should be proud of.

The work associated with club governance continues to grow as the membership increases. This is a constantly evolving and improving task and we continue to need volunteers to help with this work. I would like to thank all those who have come forward to volunteer last season and hopefully you will continue to support us with your time going forward.

As usual, our athletes have continued to perform at a very high standard with wins at most domestic regattas as well as national and international appearances and wins and they must be credited for their commitment and training.

We ran a very successful and exciting Club camp at Easter in Chester which was smaller than normal however was no less successful and consisted of members of our Senior Women, Masters Women, Masters Men and Junior Women squads. The Senior Men's squad decided to run smaller mini camps to suit their goals.

Whilst we go on to celebrate the achievements of our performance squads, we should also celebrate the large number of 'club rowers' within the Club who continue to train and improve consistently for their own pleasure and enjoyment while taking in some of the more fun regattas. This wide range of ages and aspirations makes our club an enjoyable community to be part of.

Once again, we were well represented in domestic and national events in 2023/24 and hopefully we can continue this level of attendance and performance going forward. We took wins at all levels of competition on the domestic front with our crews performing particularly well at Scottish Rowing Spring Regatta and Scottish Championships.

Nationally we attended the following:

- Rutherford Head with wins for the Masters Women and Senior Women, whilst the Junior Women, Masters Men and Senior Men all performed well.
- Women's Eights Head of the River with a Pennant Win for the Senior Women in the Challenge Category who finished 48th and our Junior Women performing well as part of the Scottish Argonauts crew.
- Vesta Masters Head where our Masters Men continued to show improvement on a national stage.
- Junior Inter Regional Regatta. With Scotland's inclusion in this event as a region, it was time for our younger Juniors to step up and shine, with fantastic performances and medals representing the Scottish Region.
- Henley Women's Regatta with our Junior Women having a fantastic run and reaching the semi finals of the Groton School Challenge Cup and ██████████ winning the Grosvenor Cup in only her second race.
- Marlow Regatta where our Senior Men had a fantastic performance in their final.
- Henley Royal Regatta where our Senior Men qualified for, and fought valiantly in, the Wyfold Challenge Cup and our Senior Women narrowly missing out on qualification for the Wargrave Challenge Cup as the fastest non-qualifiers.
- British Rowing Beach Sprints Championships where we had Junior representation who came away with a Bronze Medal.

We again renewed our end of season fun trip to Talkin Tarn which we have missed over the last few years.

Thanks must go to all of the volunteer coaches across the squads who have helped make all this happen.

The sprint season was rounded off as usual by the Home International Regatta with St Andrew Boat Club having the second highest representation of athletes only behind Edinburgh University, with three Senior Women, two Senior Men and two Junior Women all making the Squad and bringing home five Winners Medals in the process.

##### ***Fleet***

Our boat shed team continues to do a fantastic job keeping us all on the water and as ever a huge vote of thanks must go to them all.

We have added two coxed quad touring boats to the fleet thanks to a very kind donation to the Club and these are already being used regularly.

We have had a couple of major repairs this year.

##### ***Boat house/canal***

We have established a Boat House Sub Committee to look after the boat house.

██████████ has continued doing a fantastic job, connecting with Scottish Canals, organising weed cutting and canal tidy up events and taking care of the management of the Club's external spaces. This makes all of our lives much more bearable on the canal.

##### ***Volunteers***

We have had a wonderful army of volunteers again this year and a huge thanks must go to them, parents of the Juniors, as well as both the Senior and Junior athletes for all their help with boat house and canal maintenance as well as coaching and helping with younger Juniors and Learn to Rower's. There are now too many to mention individually but everyone is important to the success of the Club.

Thanks also to our section coordinators, Learn to Row co-ordinators, coaches and vice captains who give up a huge amount of time.

Thank you again to the board of Trustees who do a fantastic job in the background always with the purpose of taking the Club forward for the benefit of all members. We need to show our particular thanks to three members of this army.

Firstly, ██████████ who stood down as a Trustee at the 2024 Annual General Meeting but happily continues as Women's Vice Captain.

Secondly, ██████████ who also stood down as a Trustee at the 2024 AGM but who is not disappearing as he is continuing coach of the Senior Men's squad.

Finally, ██████████ who stood down as the Club's safety officer at the AGM but is continuing his term as a Trustee and has taken on leading the Boat House Sub Committee.

We still need more help in various areas and anyone willing to give a few hours a month of their time to benefit the Club should let any of the Trustees know.

##### **The Year Ahead**

We have a busy and exciting 2024/25 season ahead of us which front and foremost will be fundraising to finish the payment of the boat house.

We will of course be aiming to attend all of the top end regattas again this year and hopefully progress a little further than last season.

We are restructuring the rowing groups to improve the experience of rowers in the Club with the introduction of spokespersons for each group to give everyone a voice, more coaching and a clear progression plan for those wishing to progress further.

We still have very healthy waiting lists for both our Senior and Junior Learn to Row programmes and the teams are continuing to work through these as fast as possible whilst helping to make sure our retention numbers of Learn to Row graduates are high.

Due to a lack of decent club rowing at senior level within Scotland, we will be looking slightly further afield again this season to try and help with our competitiveness at all levels. We are also looking at taking more inexperienced squads to smaller events such as Nithsdale and Talkin Tarn. This always provides logistic challenges but it's one we would like to push forward on to enhance our offering to all members.

Also, as ever, due to the increasing number of members, the higher level of competition and supporting additional rowing centres, we need to turn our attention to the fleet and increasing this across the board. The requirement of additional equipment and better equipment is a good problem to have but it's still a problem and we need to fund this on a yearly basis to support our key task of rowing.

The proposed project to update and enhance the existing boat shed is still on the table and we will keep progressing with this as and when possible.

There is a major refurbishment planned for Strathclyde Park which may affect the amount of training and racing possible there for a period of time. We have been attending the consultation meetings with North Lanarkshire Council on this and are planning for all eventualities in the background. We will update people when there are any concrete developments.

Whilst we can look back on the 2023/24 season with pride, we need to look forward to next season with a renewed hunger to improve at all levels and not stand still. Keeping the Club moving forward is the key to facing and overcoming the challenges which will come our way – both on the water and off it.

##### **Financial review**

During the financial period, the charity reported a surplus of £71,424 before charging non-cash depreciation of £65,131 and a surplus of £6,293 after charging this depreciation (2023: surpluses of £46,218 and deficit of £16,323 and respectively). Income totalled £145,352 (2023: £119,961) against expenditure of £73,928 before charging non-cash depreciation and £139,059 after charging this depreciation (2023: £73,743 and £136,284 respectively).

At the year end, closing unrestricted reserves totalled £77,416 (2023: £53,673) and closing restricted reserves totalled £1,123,105 (2023: £1,140,556).

Our main source of operational funding is from membership fees and events run by the Club.

##### **Reserves policy and going concern**

The Trustees aim to hold a financial reserve sufficient to support six months normal operation of the Club which currently equates to £22,000. This financial reserve will be unrestricted funds separate from any restricted funds donated or raised for specific purposes and from any unrestricted funds that the Trustees have set aside for specific purposes.

Currently the reserves are above this level and therefore, the Trustees consider the club to be a going concern.

##### **Plans for future periods**

The club's main plans for future periods are:

- To raise sufficient funds to pay off the remaining loan associated with the new boat house.
- To compete, and be successful, at local, national and international regattas.
- To expand its membership numbers and diversity.
- To continue to improve the governance of the club.
- To amend the administration of the club to continue to cope with the club's growing membership.



##### **Constitution**

The Charity is a Scottish Charitable Incorporated Organisation, a SCIO. It was registered in its current legal form on 12 May 2015. The governing document is the constitution. The charity was previously an unincorporated association but changed its legal form to a SCIO. The assets of the unincorporated association were transferred to the SCIO on 12 May 2015. It has a single tier structure and as such the trustees are the members of the charity. As well as the trustees, there are a number of sub-committees, each governed by their own terms of reference, for particular areas of responsibility. The club also has appointed officers for roles such as Child Protection Officer and Safety Officer.



The principal accounting policies, which have been applied consistently in the current and preceding year in dealing with items which are considered material to the accounts, are set out below.

**Basis of preparation**

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standards applicable in the UK and Republic of Ireland (FRS102) issued on 16 July 2019 and the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102), the Charities and Trustee Investment (Scotland) Act 2005 and the Charities accounts (Scotland) Regulations 2006 (as amended).

The charity is a Public Benefit Entity as defined by FRS 102.

**Funds**

Funds are classified as either restricted funds or unrestricted funds, defined as follows:

Restricted funds are funds subject to specific requirements as to their use which may be declared by the donor or with their authority or created through legal processes, but still within the wider objects of the charity.

Unrestricted funds are expendable at the discretion of the trustees in furtherance of the objects of the charity. If parts of the unrestricted funds are earmarked at the discretion of the trustees for a particular purpose, they are designated as a separate fund. This designation has an administrative purpose only and does not legally restrict the trustees' discretion to apply the fund.

Transfers between funds are made on the authority of the trustees.

**Incoming resources**

Income is recognised when the charity has entitlement to the funds, any performance conditions attached to the item(s) of income have been met, it is probable that the income will be received and the amount can be measured reliably.

**Resources expended**

All expenditure is included on an accruals basis and is recognised when there is a legal or constructive obligation to pay for expenditure. All costs have been directly attributed to one of the functional categories of resources expended on the SOFA. The Charity is not registered for VAT and accordingly expenditure is shown gross of irrecoverable VAT.

All tangible fixed assets costing in excess of £1,000 having a value to the charity greater than one year are capitalised at cost. Depreciation is provided on a straight-line basis to write off the cost or initial value, less residual value, of tangible fixed assets over their estimated useful lives:

**Debtors**

Trade and other debtors are recognised at the settlement amount due after any trade discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due.

**Cash at bank and in hand**

Cash at bank and cash in hand includes cash and short term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

**Creditors and provisions**

Creditors and provisions are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement amount after allowing for any trade discounts due.

**Taxation**

Saint Andrew Boat Club is recognised as a charity for the purposes of applicable taxation legislation and is therefore not subject to taxation on its charitable activities. The charity is not registered for VAT and resources expended therefore include irrecoverable input VAT.

**Leases**

Rentals paid under operating leases are charged to income on a straight line basis over the lease term.
