All administration expenses are met by Suburban Taverns Limited, of which both trustees are directors. During the year, the trust received £30,000 of donations (2023: £30,000) from Suburban Taverns Limited.

### Reserves

At 30 September 2024, the charity had unrestricted reserves of £59,931 (2022: £62,581), which will be donated to charitable organisations in the coming years.

# Respective responsibilities of trustees and examiners
