The unrestricted funds represent £7 which is the closing balance in bank on 31ST MARCH 2025. These funds will be available for financial support of the charity in next year.

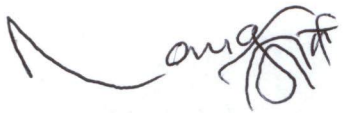
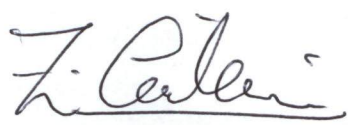
