3. Proceedings & Governance Review

Review of Financial Report: The Board formally examined the final annual financial report covering the operating period from 1 January 2025 to 31 December 2025. The Trustees verified that the income, expenditures, cash flows, and balance items accurately represent the financial operations of Amal during the year under review.
