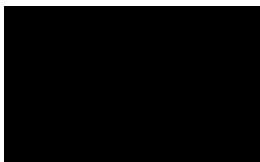
Just over £4000 was raised for us by Merchiston School in Edinburgh and deposited in the account in the account 19 February 2016.

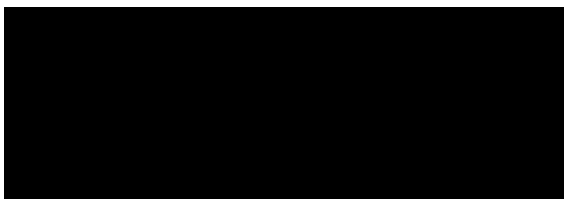
### **Basis of Independent Examiner's statement**
